The concerned Executive Engineers also remained present.

Agenda: Recommendation of new schemes for accordance of administrative approval under State Development Schemes Budget of this Department during 2018-19 out of 2<sup>nd</sup> phase of Departmental allocation for 2018-19.

Secretary took the chair. Financial Advisor, Chief Engineer (South), Chief Engineer (North), Chief Engineer (South West), Chief Engineer (North East), Chief Engineer (West) and other officers remained present.

The following were discussed:

- 1. Technically sanctioned DPR of 23 no. new schemes at an aggregate cost of Rs. 119.62 crore were initially placed for approval comprising one special infrastructure funded project. Further DPR of 6 no of new schemes were placed in the meeting.
- 2. The DSC scrutinized all the DPRs' in conformity with the Departmental manuals for lining works and those for bank protection works.
- 3. After a threadbare discussion, three schemes were discarded due to technical deficiencies and 25 No. of schemes at an aggregate cost of Rs. 165.73 crore were recommended by the DSC for accordance of administrative approval under State Development Schemes budget provisions of 2018-19 under Phase-II allocation (Annexure-I).
- 4. 1 No. of scheme at an aggregate cost of Rs. 3.13 crore was cleared under Special Infrastructure funding (Annexure-II).
- 5. Nomenclature of a few schemes was modified to make them commensurate with the capital works and some minor corrections were incorporated.
- 6. All the Chief Engineers certified that there is no duplication of proposal with any other sources of funding, and all the schemes have been selected by them on the basis of prioritized ground level requirements.
- 7. Finally 26 (twenty six) no. of new schemes at an aggregate cost of Rs. 168.86 crore were cleared by the DSC (comprising 25 no. of schemes at a cost of Rs. 165.73 crore at Annexure-I and 1 no. of scheme at an aggregate cost of Rs. 3.13 crore at Annexure-II) for

inclusion under State Development Schemes Budget and special allocation against approved schemes of Special Infrastructure projects funding.

The meeting ended with vote of thanks.
