Sub: *Handing over the charges of the jurisdiction of Hooghly Irrigation Division under Western Circle-I to Lower Damodar Irrigation Division under Damodar Irrigation Circle.*

In partial modification of this Department's Notification No. 12-W/2017-18 dated 8th August'2017 and in continuation to this Department's earlier Order No. 300-IE dated 08.08.2018, I am directed to state the following:

- a. Arambagh Irrigation Sub-Division of Hooghly Irrigation Division shall be transferred to Lower Damodar Irrigation Division alongwith its staff and working jurisdiction in the same manner as already done in case of Chandannagar Irrigation Sub-Division and Chinsurah Sub-Division of Hooghly Irrigation Division. Arambagh Irrigation Sub-Division will be under the administrative control of Executive Engineer-I, Lower Damodar Irrigation Division.

- b. Some readjustment of sanctioned strength (in terms of this Department's Notification No. 12-W/2017-18 dated, 08.08.2017) of Junior Engineer has been made and the modified sanctioned strength of Junior Engineer for Arambagh Irrigation Sub-Division and Mundeswari Irrigation Sub-Division shall be 4 and 6 instead of 5 and 5 respectively.
- c. Working jurisdiction of Mundeswari Irrigation Sub-Division of Hooghly Irrigation Division shall be transferred to Lower Damodar Irrigation Division and will be judiciously divided among Arambagh Irrigation Sub-Division and Champadanga Irrigation Sub-Division by the concerned Executive Engineer-I, Lower Damodar Irrigation Division to manage the normal workload (other than project works under WBMIFMP) of Mundeswari Irrigation Sub-Division. Executive Engineer-I, Lower Damodar Irrigation Division will maintain close liaison with Hooghly Irrigation Division (DPIU – IV) to avoid overlapping of normal work with the project works.
- d. Existing 6 Group-D Staff (including 4 Contractual) of Mundeswari Irrigation Sub-Division as has already agreed upon in consultation with the Executive Engineer, Hooghly Irrigation Division, may be posted under the control of Executive Engineer-I, Lower Damodar Irrigation Division on deployment basis to manage the normal work load of the handed over working jurisdiction of Mundeswari Irrigation Sub-Division. Executive Engineer-I, Lower Damodar Irrigation Division will further deploy them to the Arambagh Irrigation Sub-Division and Champadanga Irrigation Sub-Division as per requirement.
- e. Thus, Hooghly Irrigation Division will henceforth function as the dedicated District Project Implementation Unit-IV (DPIU – IV) with only one Sub-Division i.e. Mundeswari Irrigation Sub-Division and will only undertake project works. Executive Engineer-I, Lower Damodar Irrigation Division shall have 4 Sub-Divisions i.e. Champadanga Irrigation Sub-Division, Memari Irrigation Sub-Division, Jamalpur Irrigation Sub-Division and Arambagh Irrigation Sub-Division will look after other works in the erstwhile jurisdiction of Hooghly Irrigation Division, in addition to his own works. Executive Engineer-II, Lower Damodar Irrigation Division will continue to function as he is doing now, with 3 Sub-Divisions i.e. Singur Irrigation Sub-Division, Chandannagar Irrigation Sub-Division and Chinsurah Sub-Division. Chief Engineer (West) may further make suitable readjustment of Officers and Staff on deployment basis within the overall administrative set up of Lower Damodar Irrigation Division if required.

This order issues with the approval of Hon'ble Minister-In-Charge of this Department and to be implemented forthwith.
