The concerned officers are, hereby requested to hand over a copy of this order to each of such employees under their control, immediately. They are also requested to take further actions as enumerated below:-

The employees as promoted herein above, should be released immediately to enable them to join their new places of posting on promotion within **15(fifteen) days** from the date of issue of this order, under intimation to this office. This will not apply to the cases of those who will apply to forgo the above promotion. No prayer of change of place of posting on promotion will be accepted. So the officers concerned are hereby directed not to send thesuch prayers to this end.

The promoted employees who have already retired from service on superannuation may be deemed to have joined in the promotional post as shown against their names. After observing all formalities their pay may be fixed and the revised pension paper may be sent to the AG,A&E for revised pension by the offices from where they retired on superannuation.

The joining report in each case may please be communicated to this office in due course. The concerned Officers are also requested to intimate the respective Treasury / Pay & Accounts Office, as the case may be, accordingly.

In case of unwillingness to accept the promotion, the concerned employee will have to abide by the order dated 29-03-2011, communicated with this office memo. no. 1137(45)-CIE dated 18-04-2011 and the matter of such refusal of promotion shall have to be recorded in the **Service Book** of the concerned employee and after recording the same, the Service Book (in original) must be sent to the undersigned for necessary verification in this regard. Action will be taken in terms of Finance Department No. 9120-F dated 13.03.2000 in connection with allowing the benefit under MCAS'01 in case of refusal of promotion strictly.
