Agenda: Recommendation of new schemes for accordance of administrative approval under State Development Schemes Budget of this Department for 2019-20 under Advance Planning out of 1st phase of Departmental allocation for 2019-20.

Secretary took the chair. Financial Advisor, Chief Engineer (West), Chief Engineer (South) and other officers remained present.

The following were discussed:

- 1. Technically sanctioned DPR of 61 no. of new schemes at an aggregate cost of Rs. 137.93 crore were initially placed in the meeting for discussion.
- 2. The DSC scrutinized all the DPRs' in conformity with the Departmental manual for bank protection works.
- 3. Nomenclature of a few schemes was modified to make them commensurate with the capital works and some minor corrections were incorporated.
- 4. Schemes under S1 9, 11, 14, 15, 18, 19, 21, 37, 40, 55, 56, 57 & 58 of the meeting notice were discussed and returned due to gross deficiencies.
- 5. For the scheme under Sl 9 of Annexure, the shuttering item considered with staging is to be changed into shuttering without staging. In the scheme under Sl 14 of Annexure, the toe wall is required to be shifted towards the countryside. Porcupine cage provided at the toe wall to be removed. For the scheme under Sl 17 of Annexure, the toe wall to be eliminated. For the schemes under Sl 28 & 29 of Annexure, the cylindrical sausage work is to be eliminated.
- 6. The Chief Engineers certified that there is no duplication of proposal with any other sources of funding, and all the schemes have been selected by them on the basis of prioritized ground level requirements.
- 7. Finally, 48 (forty eight) no. of new schemes at an aggregate cost of Rs. 108.10 crore were cleared by the DSC for inclusion under State Development Schemes Budget.
- 8. Tenders are to be invited during current financial year but expenditure would be made from next FY of 2019-20.
