ORDER

The Governor has been pleased to accord permission in terms of Rule 5(2) of W.B.S.(Duties, Rights & Obligations of Govt. Employees) Rules,1980 read with No.1853-F(P) Dt..2.3.12 in favour of Sri Sushanta Bandyopadhyay, Executive Engineer, Irrigation & Waterways Department to acquire a residential flat measuring 900 sq. ft. More or less super built area at premises no.16, P.S.-Sinthee, Ramkrishna Ghosh Road, P.S.-Sinthee , Mouza-Santra Para, Touzi No.1298/2833 at Ward No.-2 within Kolkata Municipal Corporation, at the consideration price of Rs.21,00,000/- (Rupees Twenty One Lakh) only with stamp duty and other statutory Govt. duty tantamounting to Rs.23,58,019/- (Rupees Twenty Three Lakh Fifty Eight Thousand and Nineteen) only.
