**ORDER**

The Governor has been pleased to accord permission in terms of Rule 5(2) of W.B.S.(Duties, Rights & Obligations of Govt. Employees) Rules,1980 read with No.1853-F(P) Dt.2.3.12 in favour of Sri Jyotirmay Banerjee, Assistant Engineer, Metropolitan Drainage Division No.-I, Irrigation & Waterways Directorate to purchase a dwelling unit in an under construction Housing Project “AKANKSHA” – a wholly owned project of Housing Department, Government of West Bengal, of *Flat No.CL-3/401 measuring 924 Sq. Ft. (built up area) , in CL-3 Block at premises No.07/300, Block-DB, Action Area-ID* at New Town, Kolkata-700 107, at the cost of *Rs.28,64,000=00(Rupees Twenty Eight Lakh Sixty Four Thousand ) only.*

The permission is hereby accorded subject to the condition that such construction is tenable to the law as framed by appropriate authority in compliance with the Building Rules and Development Control Regulations which would be in force in New Town Area and observance of existing rules and regulations, statutes etc. as framed by local bodies/authorities and as amended time to time by authorities , along with observance of General Terms & Conditions as enshrined by Housing Department, Govt. of West Bengal, will be sole responsibility of Sri Banerjee and Government in no way will be responsible for violation or non-observance of such rules.

This order is issued subject to the condition that Sri Banerjee will remain answerable to the Govt. if any of the furnished facts/documents is found to be false/incorrect in later date.
