Agenda: Recommendation of new schemes for accordance of administrative approval under State Development Schemes Budget of this Department for 2019-20 under 2nd phase of Departmental allocation for 2019-20.

Secretary took the chair. Financial Advisor, Chief Engineer (South West), Chief Engineer (North) and other officers remained present.

The following were discussed:

1. Technically sanctioned DPR of 7 no. of new schemes at an aggregate cost of Rs. 19.93 crore were initially placed in the meeting. Further proposals for 4 no. of new scheme were placed in the meeting. One scheme was excluded due to duplication.
2. A threadbare discussion was held on the technical aspects of each of the schemes.
3. The DSC scrutinized the 10 no of DPRs' in conformity with the Departmental manuals and Codes.
4. Nomenclatures of a few schemes were modified to make them commensurate with the capital works and some minor corrections were incorporated. Cost of a few schemes was modified on technical reasons.
5. The Chief Engineers certified that there is no duplication of proposals with any other sources of funding, and all the schemes have been selected by them on the basis of prioritized ground level requirements.
6. Finally, 10 (ten) no. of new schemes at an aggregate cost of **Rs. 100.08 crore** as per enclosed list (Annexure) were cleared by the DSC for inclusion under State Development Schemes Budget of 2019-20.
7. Tenders are to be invited immediately.
