Smt. Kesang Chhoden Sherpa joined the office of the Chief Engineers, I & W. Directorate, Govt. of West Bengal as a Temporary Lower Division Assistant on 11.07.1994 F.N. in the Scale of Pay Rs.1040-1920/- [Scale No.6] (ROPA, 1990) initially. She was made permanent and confirmed w.e.f.11.07.1997 vide this office order dated 31.07.1997 bearing memo.no.3672(8)-CIE/4C-1/95 dated 12.08.1997.

Her increment was deferred by 4 months [from 01.01.2000 to 01.03.2000 and from 01.03.2001 to 01.05.2001] for **169 days of Extra Ordinary Leave.**

Then she got fixation benefit under MCAs'01 for completion of 8 years of continuous and satisfactory service w.e.f. 27.12.2002 F.N., instead of 11.07.2002 F.N. vide this office Order dated 22.02.2018 bearing memo.no.2461(7) dated 22.02.2018 in compliance of I & W. Department's No.2735-IE dated 30.10.2017 [in cancellation of order dated 30.07.2002 bearing memo.no.2399(7) dated 02.08.2002], in the first higher scale of pay Rs.3600/-7050/-[Scale No.7] (ROPA'98).

Then she got promotion to the post of U.D.A. w.e.f.01.02.2004 F.N. vide this office order dated 08.04.2004 bearing memo.no.1374(6)-CIE dated 15.04.2004 in the scale of pay Rs. 4000/-8850/- [Scale No.9] (ROPA'98), being the 3rd higher scale of her initial post. She did not get any functional or non-functional promotion between 16 to 25 years of her service period.

Now, she has completed 25 years of service under Govt. of West Bengal on 11.07.2019 A.N.

So, she is entitled to get the fixation benefit under MCAS'2001 w.e.f. 27.12.2019 F.N. in terms of Finance Deptt.'s memo.no.3015-F dated 13.03.2001 read with Circular No.DT/O/8/1-05/1649 dated 27.09.2005 of Director of Treasuries and Accounts, Govt. of West Bengal, as her increment was deferred by 4 months [from 01.01.2000 to 01.03.2000 and from 01.03.2001 to 01.05.2001] for **169 days of Extra Ordinary Leave.**

Accordingly her pay under WBS(ROPA, 2009) is fixed as follows:-
