Sub: Chief Engineer wise 'I<sup>st</sup> Additional Phase-I Departmental allocation' during the current financial year of 2019-20 under "Advance Work Plan Cycle" for the estimated cost of works to be taken up out of Core Sector State Development Schemes (SDS) budget for the next financial year of 2020-21.

The undersigned is directed to enclose herewith the approved '1st Additional Phase-I Departmental allocation' in favour of the Chief Engineer (West) and Chief Engineer (South) of this Department under Core Sector capital head of State Development Schemes budget in the next financial year of 2020-21 at an aggregate estimated cost of Rs. 44.00 crore as detailed in the Annexure to this order.

This Chief Engineer wise allocation under Advance Work Planning Cycle for incurring expenditure in the next financial year is being issued in terms of Finance (Audit) Department Memorandum No. 222-F(Y) dated 10<sup>th</sup> January 2018.

The Chief Engineers are requested to strictly comply with the limit fixed in the sectoral sub-allocations as per <u>Annexure</u> to this order and submit the technically sanctioned original copies of DPRs recommended by him to this Department for placing before the Departmental Screening Committee and subsequent administrative approval to be issued in due course through AAFS, subject to availability of requisite budgetary provisions against the concerned heads of accounts as stipulated in the Finance Department's Memo No. 1159-F(Y) dated 06.03.2020.

After obtaining clearance of the Departmental Screening Committee (DSC) and publication of 'Records of Discussion' of the DSC meeting, tenders may be invited for schemes costing within Rs. 10 crore for works and Rs. 50,000.00 for buildings etc as per delegation of power given to this Department. Work order only to be issued after accordance of Administrative Approval and financial phasing and allotment for making expenditure will commence from 1<sup>st</sup> April 2020 as per Departmental (Voted / vote-on-account) budget of 2020-21 finally approved and accepted in the WBLA in due course, again subject to availability of funds.
