The concerned Executive Engineers also remained present.

Agenda: Recommendation of new schemes for accordance of administrative approval under Advance Work Plan Cycle in 2019-20 out of State Development Schemes under Phase-I allocation for 2020-21 Secretary took the chair, Financial Adviser, Chief Engineers and other officers remained present.

The following were discussed:

- 1. It was decided that only those schemes in conformity with 1st Phase allocation under Advance Work Plan Cycle for 2020-21 would be considered for administrative approval in this financial year of 2019-20 where under the earmarked phasing of 2020-21 under a particular head of account is within 1.5 times that of provision in the voted budget of 2019-20.
- Technically sanctioned DPR of 45 no. of new schemes at an aggregate cost of Rs. 64.11 crore were initially placed in the meeting. Further proposal for 1 no. of new scheme was placed during the meeting.
- A threadbare discussion was held on the technical aspects of each of the schemes.
- 4. Nomenclatures and cost of a few schemes were modified to make them commensurate with the capital works and some minor corrections in costs were incorporated.
- Scheme No. 12, 14, 43 and 17 in the original meeting notice were dropped due to gross technical deficiencies.
- 6. The Chief Engineers certified that there is no duplication of proposals with any other source of funding, and all the schemes have been selected by them on the basis of prioritized ground level requirements matched with Departmental allocation ceiling.
- 7. Finally, 42 (forty two) no. of new schemes at an aggregate cost of Rs. 60.19 crore as per enclosed list (Annexure) were cleared by the DSC for inclusion under Advance Work Plan Cycle in 2019-20 out of proposed State Development Schemes budget of 2020-21.

Tenders are to be invited immediately for schemes costing upto Rs. 10 crore.
