Agenda: Recommendation of remaining new schemes earmarked for execution by I&WD, based on the Order passed by the Hon'ble National Green Tribunal for accordance of administrative approval under State Development Schemes under Phase-I allocation for 2020-21

Secretary took the chair at the Zoom terminal fixed at the Jalasampad Bhawan Conference Hall. Chief Engineers in the districts and other officers remained present at Jalpaiguri & Malda offices connected by Zoom App video conference.

The following were discussed:

- 1. DS-I placed the Order of the NGT.
- 2. Technically sanctioned DPR of 4 no. of new schemes at an aggregate cost of Rs. 20.97 crore were initially placed in the meeting.
- 3. All the 4 schemes were scrutinized based on the technical guidelines of the Departmental Manual for Protection works. For the scheme relating to "Raising, strengthening and improvement of Sundarban embankment for a length of 1250 m on the right bank of river Bidyadhari at Mouza Abad Malancha, Block Minakhan, P.S Minakhan, District North 24-Parganas, the Departmental Screening Committee suggested that the dry brick pitching considered should be replaced with brick block pitching gained from the past experience of failure of dry brick pitching near the same spot. The scheme was modified.
- 4. Finally, 4 (four) no. of new schemes at an aggregate cost of **Rs. 22.15 crore** as per enclosed list (Annexure) were cleared by the DSC for inclusion under State Development Schemes budget of 2020-21, if approved by the Finance Department in relaxation to the austerity measure order No. 1491-F(Y) dated 02.4.2020.
