Agenda: 17 (Seven-teen) new schemes at an aggregated cost of Rs.20.83 Crore for inclusion under Core State Development Schemes (CSDS) voted budget of Irrigation & Waterways Department during current FY of 2020-21.

Secretary took the chair and Departmental Financial Adviser with other Officers of the Department and the Directorate stationed at the Jalasampad Bhawan Head Quarters was present at Jalasampad Bhavan 1st Floor Conference Hall. Superintending Engineer Kangsabati Circle-II connected through VC.

The following were discussed:

1. Technically sanctioned DPR of 17 no. of new schemes at an aggregate cost of Rs. 20.83 crore were placed in the meeting.

- 2. A threadbare discussion was held on the technical aspects of each of the schemes.
- 3. 15 schemes having aggregated estimated cost of Rs. 8.36 crore under the jurisdiction of CE(West) relating to 'Resuscitation of drainage system' in Block Bally-Jogacha & Domjur in the district Howrah were discussed thoroughly, out of which 5 schemes (Aggregate cost Rs. 4.31 crore) were cleared and balance 10 scheme (4 in Block Bally-Jogacha & 6 in Block Domjur) posed under Sl. 1 to 5, 7, 8,10, 12 & 13 of the 'Proposed List' were dropped considering the present fund situation.
- 4. Another scheme relating to 'Resuscitation of drainage system 'at Chakpara Ananda Nagar GP in Block Bally-Jogacha at a cost of Rs. .99 crore was cleared.
- 5. Thus, the said 6 schemes in the jurisdiction of Zila Parisad, Howrah require 'NoC' and/or necessary certificate form Zila Savadhipati of Howrah before processing of Formal Administrative Approval by this Department. Instant clearance has now been accorded only to allow those 6 schemes for consideration of FD for taking up as new schemes in 2020 in relaxation to the existing orders and also in anticipation that such 'NoC' will be produced before processing of Formal Administrative Approval.
- 6. 2 schemes under Sl 16 & 17 of the 'Proposed List' were cleared. For the scheme under Sl. 17 i.e 'Construction of RCC Bridge over TSMC (N) at Ch. 1468.90 at Ledhabahara', the Statutory Certificates for CSDS schemes should be corrected by the concerned Executive engineer before processing of Formal Administrative Approval.
- 7. Another Scheme relating to 'Construction of RCC Bridge over Joyfully Khal at Mouza Bahir Agar (Rs. 101.73 Lakh)' in Purba Medinipur District was also cleared by the said committee as additional scheme considering its importance.
- 8. The Chief Engineers certified that there is no duplication of proposals with any other sources of funding, and all the schemes have been selected by them on the basis of prioritized ground level requirements.
- 9. Finally, 9(Nine) new schemes at an aggregate cost of Rs. 18.80 crore as per enclosed list (Annexure) were cleared by the DSC for consideration by the Finance Department for inclusion under Core State Development Schemes (CSDS) budget of I&WD under Demand No. 32, B.P no 18 during the current FY 2020-21 in relaxation to the existing orders.
