I&WD has long published the latest standard NIT format vide this Department No. 344-IB dated 3rd December 2019. In the said order it is clearly mentioned that any subsequent order of the Department, and the Finance Department is binding and are to be strictly followed and the NIT format may be modified accordingly, by the Tendering Authorities.

This Department issued an order debarring splitting of works vide Memo No. 389-IB dated

20.12.2019. In addition to above, Finance Department has issued orders debarring splitting of works vide their No. 284-F(Y) dated 16.01.2020 read with Finance Department No. 4609-F(Y)

dated 18.07.2018.

The matter has again been discussed in the Departmental Review Meeting held on 26.11.2020

chaired by the Additional Chief Secretary of this Department in presence of the Secretary and

the Financial Advisor.

All contradiction contained ibid under special terms and conditions of the NIT format

communicated vide this Department No. 344-IB dated 3rd December 2019 contained under para

2, stands automatically cancelled, from the date of issuance of the Finance Departmental orders

read with this Departments' order referred earlier.

For contradictions, if any, in the WB 2911 format published vide Finance Department No. 5696-

F(Y) dated 01.10.2019, a separate file will be moved to clear all ambiguities upon receipt of

proposals from the Chief Engineers.

a) It may be noted where ever more than one L1 bids are received in any tender, the same has to

be cancelled and re-tendered afresh.

b) Splitting of projects prior to tendering is debarred in terms of Finance Department guidelines.

This order is being issued reiterating the same for strict compliance of all tendering authorities.
