Sub: Technical Examination of Plan Projects.

The undersigned is directed to state that the necessity of technical examination of plan projects executed by this Department so as to justify the expenditure incurred out of the State exchequer and to evaluate the extent of acquaintance of the implementing officials about the existing rules, regulations, guidelines and functional responsibilities, has since been detailed out in the Irrigation & Waterways Department Order No.29(W)/2016-17 dated 9th November, 2016.

- 2. Composition of the departmental Technical Examination Teams (TETs) and modalities as well as standardised checklist for undertaking such technical examinations have also been brought out in the above said order.
- 3. The composition and ID nos. of the Teams have been shown at enclosed Annex. Chairpersons of the TETs are requested to henceforth use and quote this ID nos. in their reports and references.
- A. Now the undersigned is directed to assign the projects implemented by various Irrigation Divisions among the TETs for undertaking technical examination on the basis of two plan projects per team as shown in the Annex. Such examinations are to be carried out in accordance with the guidelines, checklist and modalities contained in the Order, stated in Para-1 above. Hard and soft copies of the report, including the final comments of TETs and other relevant information as detailed in Para-C of the standardized format containing Checklist (Annexure-II of the Order stated in Para-1 above), should be submitted to the Secretary of this Department. Audio-visual evidences taken / collected during the examination should be appended to the report as Annexure. In addition, Chairpersons of the TETs are requested to prepare a short Power Point Presentation (PPT) on the entire process of examination, highlighting, inter-alia, the following:
 - a) A brief introduction.
 - b) Salient features of the scheme examined, including name, estimated cost, completed cost, location Block & PS and District, funding source (i.e. CSP / RIDF etc.), purpose / justification of the schemes, dates of commencement of work at site and the target, vis-à-vis the actual completion and benefits accrued after implementation of the scheme.
 - c) A brief description of documents examined.
 - d) Dates of field visits (including interaction with local people), findings of such visits, along with photographs and videos of pre-work and post-work (collected from concerned executing Division) and present condition (taken by TET). Videos of interaction with local people about the benefit of the scheme shall also be taken.
 - e) Final comments of TET (in maximum 2 slides) on.
 - i) Observance of prescribed rules during tendering process:
 - ii) Maintaining timeframe of execution and reasons of time extension, if any;
 - iii) Steps taken for adherence to quality assurance plan during execution at worksite; and
 - iv) Any suggestions / lessons learnt to expedite the execution.

Total number of slides of the PPT should not be too large. The PPT should also include video clips as required.

5. Chairpersons of the TETs would be invited to show the PPT in review meetings to be taken by Hon'ble MIC / Additional Chief Secretary / Secretary.

- 6. Following time schedule is to be followed in this regard:
 - a) Completion of examination of the project by 31st March 2021.
 - b) Submission of report to this Department by 19th April 2021.
- 7. All concerned may be informed accordingly.
