Agenda: Recommendation of 2 (two) new schemes for inclusion under Core State Development Schemes (Voted) budget of Irrigation & Waterways Department during the current FY of 2020-21.

Secretary took the chair.

The following were discussed:

- 1. Technically sanctioned DPRs of 2 no. of schemes at an aggregate cost of Rs. 3.81 crore were placed in the meeting.
- 2. The 1st scheme is related to construction of cement concrete approach road to the RCC Bridge along the left embankment of Dehaty khal. The Superintending Engineer, Western

Circle-III and the Executive Engineer, East Midnapore Division explained that this approach road is required to be constructed as the approach is proposed parallel to the NH-6 for smooth entry of vehicular traffic from the bridge across Dehaty khal. The land of the Dehaty khal embankment belongs to I&W Department. It was stated that the design

of the RCC retaining wall on the canal side of the approach road has been checked and found to be technically safe by the Executive Engineer and the Superintending Engineer.

For the 2nd scheme relating to remaining work for rehabilitation of Dauk Barrage under Phase-III, the Chief Engineer, Teesta Barrage Project stated that this work is technically required so that, the result of the works executed under Phase-I & II are sustained. It was stated that the works under Phase-I & II have been completed.

3. The Chief Engineers stated that both the schemes have been selected by them on the basis of prioritized ground level requirements.

4. Thus, 2 (two) no. of new schemes at an aggregate cost of Rs. 3.81 crore as per enclosed list (Annexure) were cleared by the DSC for inclusion under Core State Development Schemes budget of I&WD under Demand No. 32, B.P no 18 during the current FY 2020-21 under delegated power to the Department.
