Agenda: Recommendation of 8 (eight) new schemes for inclusion under Core State Development Schemes (Voted) budget of Irrigation & Waterways Department during the current FY of 2020-21.

Secretary took the chair.

The following were discussed:

- 1. Technically sanctioned DPRs of 8 no. of schemes at an aggregate cost of Rs. 47.82 crore were placed in the meeting.
- 2. The 7 (seven) schemes under Sl. 1 to 7 of the <u>Annexure</u> are related to development of Singur Project area, on land not belonging to I&WD. The works have been assigned to the Irrigation & Waterways Department for execution for which NoC of the District Administration/Land owners may be obtained prior to commencement of the works.

- 3. The scheme under SI 8 relates to re-sectioning of a channel within river Kaliaghai for a length of 14.5 km for providing immediate relief from water logging during monsoon in vast areas under P.S Patashpur, Bhagawanpur, Moyna and Sabang. The comprehensive plan to be followed for providing a comprehensive and sustainable benefit in the Kaliaghai-Kapaleswari-Baghai drainage sub basin includes the instant proposal of desiltation under Phase-I, and proposal for construction of a regulator at Chabukia (Mini barrage type) under Phase-II. While Phase-I works may be taken up right now, the combined plan of action includes taking up the construction of regulator under Phase-II from next year onwards, so as to minimize the gap between completion of Phase-I and Phase-II works. Accordingly, CDO, I&WD was requested to finalise the design and drawing of the regulator by March, 2021.
- 4. Thus, 8 (two) no. of new schemes at an aggregate cost of **Rs. 47.99 crore** as per enclosed list (Annexure) were cleared by the DSC for inclusion under Core State Development Schemes budget of I&WD under Demand No. 32, B.P No. 18 during the current FY 2020-21.
- 5. Formal administrative approval will be processed in as per usual procedure in due course in terms of guidelines of the Finance Department.
