Sir/Madam,

I am directed to refer to the Notification No. 192-IT/06/2020/P&AR-e-Gov dated 16.10.2020 bringing IT Personnel working in regular establishments under the State Government and/or any Project under the Govt., who have been engaged through agencies, under direct control of Government as Contractual Workers w.e.f. 01.11.2020 with a view to improving the service conditions of such personnel and to say that in terms of the said Notification certain service benefits have been allowed but the same does not speak anything about entitlement of remuneration of such personnel and the relevant Head of account against which the charge shall proceed, as a result of which a good number of references from various Administrative Department's are being received regarding the same.

Till finalization of remuneration of such personnel, it has been decided that they will continue to receive the same amount of remuneration w.e.f. 01.11.2020 as was being drawn by each individual prior to 01.11.2020 and the charge for the same shall proceed against '02-Wages' Head of account.

I am accordingly directed to request that the decision of the Government as mentioned in the 2^{nd} para above may please be adhered to by all concerned.
