The concerned Executive Engineers also remained present.

Agenda: Recommendation of 2 (two) new schemes for inclusion under Core State Development Schemes (Voted) budget of Irrigation & Waterways Department during the current FY of 2021-22.

Secretary took the chair.

The following were discussed:

- 1. Technically sanctic ned DPR of 2 no. of schemes at an aggregate cost of Rs. 2.85 crore were placed in the meeting.
- 2. A threadbare discussion was held on the technical aspects of each of the two schemes.
- 3. The scheme relating to renovation of High Tension Electrical Substation including replacement of existing faulty rising mains and replacement of LT panel of Jalasampad Bhawan, is urgently required to be commissioned as the existing electric power distribution system is being done through a stop gap arrangement since 2017 after the

main raisers were damaged and thus such a temporary system is prone to a major accident in a multi storied office building like Jalasampad Bhavan. A complete overhauling and modernization with all safety precaution have been proposed in the DPR.

- 4. The 2nd scheme relating to Supply installation & commissioning of Intelligent addressable fire detection & auto-alarm system for Jalasampad Bhawan comprising 3 (three) building blocks is immediately required to be implemented. The Phase-I of the fire protection system comprising the mechanical and civil works have been more or less completed. The scheme under Phase-I utilises the modern technology for dousing a fire and simultaneously providing safe passage for escape with minimum damage to properties using wet (water jet) and dry (chemical spray) mechanisms. The instant scheme under Phase-II involves electronic automatic fire detection and alarm system. The scheme also comprises obtaining clearance from the Fire & Emergency Services Department, GoWB and also operation maintenance charges including 24 hours manning of the fire protection and detection system for next five years period. The item rates have been justified by the concerned Superintending Engineer and Chief Engineer and recommended by them as fair and reasonable.
- 5. Thus, 2 (two) no. of new schemes at an aggregate cost of **Rs. 2.85 crore** as per enclosed list (Annexure) were cleared by the DSC for inclusion under Core State Development Schemes budget of I&WD under Demand No. 32, B.P no 18 during the current FY 2021-22 under delegated power to the Department.
