Agenda: Proposal for recommendation of 9 (nine) new schemes for inclusion under Core

State Development Schemes (Voted) budget of Irrigation & Waterways

Department during the current FY of 2021-22.

Secretary took the chair.

The following were discussed:

 DPR of 9 no. of schemes included in the list of 107 schemes selected in the Departmental Review Meeting taken by Hon'ble MIC on 13.07.2021 were initially placed in the meeting. However, the scheme for Ranichak Pump House Phase-II was set aside for review of its technical feasibility.

- 2. Scheme under Sl 1 being above Rs. 5 crore values has been technically recommended by the Departmental Technical Committee of Chief Engineers in their 263rd meeting held on 10.12.2020. The remaining schemes under Sl 2 to 8 have been technically cleared by the Directorate Level Technical Committee in their 5th Meeting held on 13.08.2021.
- 3. After thorough scrutiny it was found that DPR for the scheme under Sl 5 under Mechanical & Electrical Division, Midnapore initially had provisions for replacement of 2 no. of fall board shutters of the anicut structure. However, another fall board structure is found to be required. Hence, the DSC instructed inclusion of all the three fall board shutters and accordingly the scheme was modified now having cost of Rs. 61.85 lakh.
- 4. The name of the scheme under SI 6 has been modified commensurate with the actual work.
- 5. As regards to the scheme under Sl 8 relating to the VVIP Bungalow at Malda, the civil construction has almost been completed by the Malda Irrigation Division, I&WD. As desired by the State Government at the appropriate level and policy of the Government for VVIP Bungalows, the electrical works have been entrusted with the PWD Electrical Directorate as a deposit work amounting to Rs. 35.48 lakh. PWD Electrical Directorate being the competent authority of the State Government, the scheme is cleared by the Directorate Level Technical Committee as well as recommended by the DSC.
- 6. Finally all the schemes have been cleared by the DSC for inclusion under Core State. Development Schemes budget of I&WD under Demand No. 32, B.P no 18 during the current FY 2021-22. However, one of the scheme (under Sl. 1) needs to be submitted to the Finance Department for administrative approval and the remaining 7 (seven) schemes (Sl 2 to 8) may be approved under delegated Departmental power for administrative approval, each costing within Rs. 1.5 crore.
