Minutes of the State Executive Committee(SEC) Meeting of the WBSDMA held on 13.08.2021.

The State Executive Committee met today i.e. on 13.08.2021 in the chamber of the Chief Secretary at 12 noon. The salient points of the discussions and decisions are submitted as follows:

- 1) After review of COVID data from Health & Family Welfare Department, it was observed that the restriction measures imposed from May, 2021 and extended till 15<sup>th</sup> August, 2021 vide memo no. 753-/IV-ISS/2M-22/2020 dated 29.07.21 have had a beneficial effect of reducing the COVID cases in West Bengal. It was decided to further recommend extending the restrictions in a gradual and calibrated manner from another two weeks in a manner that while keeping mobility and human contact at minimum level, some of the activities both in private and government can commence as per draft at flag X the relaxations would allow outdoor government programmes and opening of theatre halls, auditoriums/open air theatres etc. with not more than 50% capacity.

Stadiums and swimming pools may remain open with 50% capacity. The shops and establishments including restaurants and allowed to open upto 8 pm can now remain open upto usual working hours but not beyond 10.30 pm. Outdoor activities/movements remain prohibited between 11 pm to 5 am except for health, law & order, essential commodities and emergency services.

- 2) Revision of House Buildings Grants to Rs. 20,000 for fully damaged kutcha house instead of Rs. 17,600/ and a standard rate of Rs. 5,000/ for partially damaged houses of all categories was approved.

The State Executive Committee met today i.e. on 28.08.2021 in the chamber of the Chief Secretary at 11 am. The salient points of the discussions and decisions are submitted follows.

- 1) After review of COVID data from Health & Family Welfare Department, it was observed that the restriction measures imposed from May, 2021 and extended till 15<sup>th</sup> August, 2021 vide memo no. 753-/V-ISS/2M-22/2020, dated 13.08.21 and read with order no. 753-/VI-ISS/2M-22/2020, dated 16.08.21 have had a beneficial effect of reducing the COVID cases in West Bengal. It was decided to further recommend extending the restrictions in a gradual and calibrated manner for another two weeks in a manner that while keeping mobility and human contact at minimum level, some of the activities both in private and government can commence as per draft annexure X.

The additional relaxation for coaching centres for competitive examinations to remain open with 50% capacity was allowed. Outdoor activities/movements remain prohibited between 11 pm to 5 am except for health, law & order, essential commodities and emergency services.

- 2) It was decided that 24 Multipurpose Rescue Shelters for use during Cyclone/Flood and other natural calamity would be constructed from State Disaster Mitigation Fund. Fifteen Multipurpose Rescue Shelters would be in South 24 Paraganas, five in Purba Medinipur and four in North 24 Paraganas.
