Agenda: Recommendation of new schemes identified in the Departmental Review Meeting

taken by Hon'ble Minister-in-Charge held on 13.07.2021 for inclusion under Core State Development Schemes (Voted) budget of Irrigation & Waterways Department during the current FY of 2021-22.

Secretary took the chair.

The following were discussed:

- DPR of 29 no. of new projects out of 107 primarily identified schemes having an aggregate estimated cost of Rs. 32.78 crore were placed before the Departmental Screening Committee for consideration.
- 2. Out of these 29 schemes, 17 no. of schemes have been technically cleared by the Directorate Level Technical Committee in their 8<sup>th</sup> Meeting held on 10.09.2021, 1 no. of scheme technically cleared by the Directorate Level Technical Committee in their 7<sup>th</sup> Meeting held on 31.08.2021, another 1 (one) no. technically cleared by the Directorate Level Technical Committee in their 5<sup>th</sup> Meeting held on 13.08.2021, 3 no. of schemes have been technically cleared by the Directorate Level Technical Committee in their 10<sup>th</sup> Meeting held on 05.10.2021 and further 7 no. of schemes have been technically cleared by the Directorate Level Technical Committee in their 11<sup>th</sup> Meeting held on 07.10.2021.
- 3. After a threadbare deliberation, 10 no. of schemes having an aggregate estimated cost of Rs. 9.22 crore were finally cleared by the DSC with the approval of the highest authority of this Department for inclusion under Core State Development Schemes budget of I&WD under Demand No. 32, B.P no 18 during the current FY 2021-22.
- 4. The following schemes were directed for re-submission after necessary corrections:
  - Re-construction of Kankandighi sluice on river Raidighi (Rs. 44.95 lakh) to be reframed as per standard drawing and design of the Central Design Office.
  - ii) Construction of double vented hump pile sluice on river Dansa (Rs. 131.54 lakh) to be re-framed based on standard drawing and design of the Central Design Office.
  - iii) Renovation of 12 no. sluice gates on left embankment of river Dwarakeswar (Rs. 91.68 lakh) to be re-submitted with drawing and design of gates and other relevant supportive documents.
- 5. The technically sanctioned DPRs for 10 no. of schemes as per Annexure is recommended inclusion under Core SDS budget of this Department during 2021-22 in terms of delegated power under Finance Department Memorandum No. 1971-F(Y) dated 30.06.2021.
