Agenda: Proposal for recommendation of 10 (ten) new schemes for inclusion under Core State Development Schemes (Voted) budget of Irrigation & Waterways Department during the current FY of 2021-22.

Secretary took the chair.

The following were discussed:

1. DPR of the 10 no. of schemes included in the list of 107 schemes, primarily selected in the Departmental Review Meeting taken by Hon'ble MIC on 13.07.2021, were placed in the meeting.

- 2. Schemes placed in the meeting have been technically recommended by the Directorate Level Technical Committee in their 6th meeting held on 23.08.2021. The remaining schemes under SI 9 & 10 have been technically cleared by the Directorate Level Technical Committee in their 5th Meeting held on 13.08.2021.
- 3. On the basis of subsequent decision taken at the highest level of the Government, and the Government in the Irrigation & Waterways Department in the review meeting held on 16.11.2021, only 1 no. scheme is presently being recommended for inclusion under Core State Development Schemes budget of I&WD under Demand No. 32, B.P no 18 during the current FY 2021-22, as stated below.
- 4. 'Protection to the Rup-Right Schedule 'D' embankment in between house Kanai Tung and house of Sukumar Maity for a length of 120 m in Mouza Bar Amritberia, Block & P.S Mahisadal, District Purba Medinipur'at a cost of Rs 39.92 lakh
- 5. The technically sanctioned DPR of the above as per DSC clearance may be submitted in soft copy for processing for administrative approval under delegated Departmental power for administrative approval.
