Agenda: Recommendation of new prioritized schemes for inclusion under Core State Development Schemes (Voted) budget of Irrigation & Waterways Department during the current FY of 2021-22.

Secretary took the chair.

The following were discussed:

 DPR of 4 no. of new projects out of the 107 primarily short listed schemes in the Departmental Review meeting taken by Hon'ble MIC on 13.07.2021 having an aggregate estimated cost of Rs. 3.68 crore were placed before the Departmental Screening Committee for consideration (Sl 1 to 4 in the Annexure). Four more schemes relating to rejuvenation of lower and upper Bagjola khal. New Cut-Kestopur khal, and Bhangore Kata khal prepared in compliance of the order of the Hon'ble National Green Tribunal were placed during the meeting. (Sl 5 to 8 in the Annexure)

- 2. Out of these 8 schemes, 2 no. of schemes have been technically cleared by the Directorate Level Technical Committee in their 8th Meeting held on 10.09.2021, 1 no. of scheme technically cleared by the Directorate Level Technical Committee in their 5th Meeting held on 13.08.2021, 1 no. of scheme technically cleared by the Directorate Level Technical Committee in their 6th Meeting held on 23.08.2021, and remaining 4 (one) no. schemes under the jurisdiction of Chief Engineer (South), each costing above Rs. 1.5 crore technically cleared by the Departmental Technical Committee of Chief Engineers in their 284th Meeting held on 08.12.2021.
- 3. After a threadbare deliberation, 4 no, of schemes from Sl. 1, 2, 3 & 4 were cleared by the DSC in terms of delegated power under Finance Department Memorandum No. 1971-F(Y) dated 30.06.2021.
- 4. The schemes from Sl 5 to 8 have been prioritized based on the order of the Hon'ble NGT in which an Affidavit has been submitted by the Irrigation & Waterways Department to take up execution from December 2021. This scheme would require approval of the Finance Department.
- 5. The DSC hence recommended all the 8 (eight) schemes at an aggregate estimated cost of Rs. 137.19 erore, for inclusion under Core State Development Schemes budget of I&WD under Demand No. 32, B.P no 18, during the current FY 2021-22.
- 6. Tenders may be invited for the schemes which are not violating the Model Code of Conduct of Elections.
