Agenda: Recommendation of new schemes identified in the Departmental Review Meeting taken by Hon'ble Minister-in-Charge held on 13.07,2021 for inclusion under Core State Development Schemes (Voted) budget of Irrigation & Waterways Department during the current FY of 2021-22.

Secretary took the chair.

The following were discussed:

 DPR of 5 no. of new projects out of 107 primarily identified schemes in the Departmental Review meeting taken by Hon'ble MIC on 13.07.2021 having an aggregate estimated cost of Rs. 5.73 crore were placed before the Departmental Screening Committee for consideration. Later one more emergent scheme was included during the meeting under Canals Division, Irrigation & Waterways Directorate.

- 2. Out of these 6 schemes. 2 no. of schemes have been technically cleared by the Directorate Level Technical Committee in their 11th Meeting held on 07.10.2021, 2 no. of scheme technically cleared by the Directorate Level Technical Committee in their 8th Meeting held on 10.09.2021, 1 no. of scheme technically cleared by the Directorate Level Technical Committee in their 15th Meeting held on 01.12.2021, another 1 (one) no. technically cleared by the Directorate Level Technical Committee in their 6th Meeting held on 23.08.2021.
- After a threadbare deliberation, 4 no. of schemes under Sl. 1, 2, 3 & 5 were cleared by the DSC in terms of delegated power under Finance Department Memorandum No. 1971-F(Y) dated 30.06.2021.
- 4. The scheme under SI 6 was modified to exclude ancillary works like bituminous road etc. and only canal excavation was considered at a revised cost of Rs. 1.50 crore. The scheme under SI 4 relates to protection work on the left embankment of Diamond Harbour Creek khal at Santhipally for a length of 100.00 m in Ward No. 14 of Diamond Harbour Municipality costing Rs. 1.89 crore. This scheme would require approval of the Finance Department. The remaining 5 schemes are within the delegated power of administrative approval conferred to this Department. The DSC hence recommended all the 6 schemes at an aggregate estimated cost of Rs. 6.99 crore, for inclusion under Core State Development Schemes budget of I&WD under Demand No. 32, B.P no 18 during the current FY 2021-22.
