ORDER

This is to state that Geographic Information System (GIS) based cross-section survey of all important drainage canals located in and around Kolkata under the working jurisdiction of Chief Engineer (South), Irrigation & Waterways Directorate is being carried out by concerned Investigation & Planning Division (South) under the technical guidance of Chief Engineer (Design & Research) using Differential Global Positioning System (DGPS) based Real-Time Kinematic (RTK) survey equipments and Acoustic Current Doppler Profiler (ADCP), in terms of the Departmental Order No. 140-IFC dated 27.07.2021.

Now, it has been decided based on the findings of the Chief Engineer (Design & Research), Irrigation & Waterways Directorate to adopt this GIS based mode of survey during re-excavation/de-siltation of all important major drainage channels located in and around Kolkata and those located within Howrah Municipal Corporation under the administrative jurisdiction of the Irrigation & Waterways Department.

Henceforth, for all capital works which have been tendered, to be tendered relating to major drainage channels in and around Kolkata and those within Howrah Municipal Corporation area, pre-works, intermediate post works, final post works, are to be measured for payment of bills using DGPS based RTK / ADCP only, until further orders.

For all capital de-siltation / re-excavation works of major drainage channels in and around Kolkata and within Howrah Municipal Corporation area, a suitable corrigendum /

addendum, is to be inserted in the e-tenders (with newspaper publicity) so that the interested bidders are made aware of the aforesaid Government policy and that the successful bidders shall have to arrange for hiring of such DGPS survey instruments for measurement of works. Their bid prices should take into account of this modification.
