Agenda: Proposal for recommendation of 08 (eight) new schemes (08 no. schemes costing above Rs 5.0 crore) for inclusion under "Special Assistance of 2022-23" for Irrigation & Waterways Department.

Secretary took the chair. The following were discussed:

Total eight (08) schemes were discussed during the meeting under EE-I, Joynagar Irrigation Division, EE-II Joynagar Irrigation Division, East Midnapur Division, Ganga Anti Erosion Division-I, Berhampoore Irrigation Division of I.&W. Directorate,

1. 01 scheme (under sl 1) technically recommended by the 295th Departmental Technical Committee of Chief Engineers held on 23.03.2022 . 01 scheme (under sl 2) technically recommended by the 296th Departmental Technical Committee of Chief Engineers held on 25.05.2022. These 02 Schemes have been placed in the present DSC meeting and recommended with some modification in name of work.

2. 01 scheme (under sl 3) technically recommended by the 293th Departmental Technical Committee of Chief Engineers held on 12.04.2022 . 01 scheme (under sl 4) technically recommended by the 288th Departmental Technical Committee of Chief Engineers held on 11.02.2022. 02 scheme (under sl 5,6) technically recommended by the 296th Departmental Technical Committee of Chief Engineers held on 25.05.2022. These 04 Schemes have been placed in the present DSC meeting and recommended with some

modification in name of work.

3. 02 schemes related to re-excavation of Soadighi khal and Gangakhali khal within blocks Paskura, Kolaghat, Tamluk & Sahid Matangini ,Dist :Purba Medinipur under East Midnapur Division technically recommended by the 295th Departmental Technical Committee of Chief Engineers held on 23.03.2022 . These 02 schemes have been placed in present DSC. It has been decided that concerned Executive Engineer will carry out a soil sample test of the silt to be removed through RRI and send a proposal of de-siltation with the aforesaid soil test report to the Department. The same ,in turn, will be sent to WBMTDCL for carrying out the proposed de-siltation work.

Finally, 06 nos. schemes as per Annexure have been cleared by the DSC for inclusion within "Special Assistance of 2022-23" out of SDS voted Budget under Demand No. 32, B.P No 18 during the current FY 2022-23.

It has been directed to submit the soft copy (PDF version) of all the schemes as per enclosed list duly technically sanctioned after incorporation of the minor changes as suggested in the DSC meeting.
