Total 07 (seven) schemes were discussed during the meeting under Malda Irrigation Division, Kakdwip Irrigation Division, Mograhat Drainage Division, Suburban Drainage Division Jhargram Flood Management & Planning Division, West Midnapur Division, Kangsabati Canals Division No. V of I.&W. Directorate,

- 01 scheme (under sl 1) related to bank protection work along left bank of river Ganga in P.S.: Bhutni, Dist: Malda, technically recommended by the 297th Departmental Technical Committee of Chief Engineers held on 06.06.2022. This scheme has been placed in the present DSC meeting and recommended with some minor modification in attachment of documents in said scheme.
- 2. 01 scheme (under sl 2) related to construction of Sundarban embankment in P.S.: Frezarganj Coastal, Dist: South 24 Pgs technically recommended 296th Departmental Technical Committee of Chief Engineers held on 25.05.2022. This scheme has been placed in the present DSC meeting and recommended with some minor modification in attachment of documents in said scheme.

 - 01 scheme related to construction of 10 vent sluice over Tamillya khal, at Mansukha in P.S.: Ghatal, Dist: Paschim Medinipur under West Midnapur Division technically recommended 297th Departmental Technical Committee of Chief Engineers held on 06.06.2022.

recommendation from Departmental Technical Committee of Chief Engineers of this

Department.

in consultation with the Central Design Office, I&WDte. & resubmitted in forthcoming

DSC meeting after due recommendation from Departmental Technical Committee of
