Agenda: Proposal for recommendation of 10 (ten) new schemes (10 schemes costing above Rs 5.0 crore) for inclusion under "Special Assistance of 2022-23" for Irrigation & Waterways Department.

Secretary took the chair. The following were discussed:

Total 10 (ten) schemes were discussed during the meeting under Mahananda Embankment Division, Malda Irrigation Division, Metropolitan Drainage Division No.-I, Mograhat Drainage Division, Suburban Drainage Division , Jalpaiguri Irrigation Division, Damodar Canal Division, Damodar Headworks Division, Contai Irrigation Division of I.&W. Directorate,

- 01 scheme (under sl 1) related to bank protection work along right bank of river Mahananda in Block.: Ratua-II, Dist: Malda, technically recommended by the 298th Departmental Technical Committee of Chief Engineers held on 24.06.2022. This scheme has been placed in the present DSC meeting and recommended with some minor modification in attachment of documents in said scheme.
- 2. 01 scheme (under sl 2) related to raising and strengthening of Sambalpur Circuit Embankment in Block.: Ratua-II, Dist: Malda, technically recommended by the 298th Departmental Technical Committee of Chief Engineers held on 24.06.2022. This scheme has been placed in the present DSC meeting and recommended with some minor modification in attachment of documents in said scheme and name of work.
- 3. 01 scheme (under sl 3) related to bank protection work along right bank of river Tangon in Block.: Gazole, Dist: Malda, technically recommended by the 298th Departmental Technical Committee of Chief Engineers held on 24.06.2022. This scheme has been placed in the present DSC meeting and recommended with some minor modification in attachment of documents and drawings in said scheme.
- 4. 01 scheme (under sl 4) related to construction of additional pump house near outfall of Lower Bagjola khal at Kulti ,Block-Haroa ,Dist-North 24 Pagranas technically recommended by the 297th Departmental Technical Committee of Chief Engineers held on 06.06.2022 .This scheme has been placed in the present DSC meeting and recommended with some minor modification in attachment of documents and drawings in said scheme.

5. 01 scheme (under sl 5) related to construction of 08 vent sluice over Hobka khal, at Dhosa in Block.: Jaynagar-I, Dist: South 24 Parganas technically recommended by the 298th Departmental Technical Committee of Chief Engineers held on 24.06.2022.

01 scheme (under sl 6) related to construction of 11 vent sluice over Charial Diversion Channel ,at Pujali in Block- Budge Budge ,Dist :South 24 Parganas technically recommended 298th Departmental Technical Committee of Chief Engineers held on 24.06.2022.

All these 02 schemes have been re-submitted in the present DSC meeting after due compliance of directives of RoD of DSC meeting dated 16-06-2022 and recommended. It has been resolved that for these 02 schemes separated tenders are to be invited by the "Civil wing" as well as "Mechanical-Electrical wing" of Irrigation & Waterways Directorate having territorial jurisdiction, based on individual technically sanctioned amount as considered within said 02 schemes, for the interest of work.

- 6. 01 scheme (under sl 7) related to bank protection work along both bank of Hatinala within block-Dhupguri, Dist-Jalpaiguri technically recommended 298th Departmental Technical Committee of Chief Engineers held on 24.06.2022. This scheme has been placed in the present DSC meeting and recommended with some minor modification in attachment of documents ,drawings and scope of work in said scheme with due consultation of the Central Design Office , Irrigation & Waterways Directorate.
- 7. 01 scheme (under sl 8) related to bank protection work along right bank of River Damodar within block- Jamalpur, Dist-Purba Burdwan technically recommended 298th Departmental Technical Committee of Chief Engineers held on 24.06.2022. This scheme has been placed in the present DSC meeting and recommended with some minor modification in attachment of documents, drawings and scope of work in said scheme.

8. 01 scheme (under sl 9) related to bank protection work along right bank of River

Rasulpur at three different locations within Block- Deshopran , Dist-Purba Medinipur

technically recommended by the 297th Departmental Technical Committee of Chief

Engineers held on 06.06.2022. This scheme has been placed in the present DSC meeting

and recommended with some minor modification in attachment of documents and name

of work.

9. 01 scheme related to bank protection work along right bank of River Ajoy at Ramnagar

G.P. within Block- Aushgram, Dist-Purba Burdwan under Damodar Headworks

Division technically recommended by the 298th Departmental Technical Committee of

Chief Engineers held on 24.06.2022. This scheme has been placed in the present DSC

meeting and resolved that the scheme booklet is to be reframed in consultation with the

Central Design Office, I&WDte. & resubmitted in forthcoming DSC meeting after due

recommendation from Departmental Technical Committee of Chief Engineers of this

Department.

within "Special Assistance of 2022-23" out of SDS voted Budget under Demand No. 32,

B.P No 18 during the current FY 2022-23.
