Two schemes (under sl 1, 2) for protection work along left bank of river Mahananda (Nagri) at G.P.- Gulandar-I and Marnai "Block –Itahar "Dist: Uttar Dinajpur under Executive Engineer, North Dinajpur Irrigation Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 39th Meeting held on 08.06.2022. These 02 schemes have been placed in the present DSC meeting and recommended with some modification in name of work as well as some attachment within scheme booklet.
- 2. One scheme (under sl 3) for construction of one RCC Bridge over Alampur khal at Sonapur, in replacement of old dilapidated bridge at Sonapur, Block- Budge Budge –II, Dist- South 24 pgs under Executive Engineer ,Subarbun Drainage Division initially technically recommended by the Directorate Level Technical Committee of I&WDte. in their 57th Meeting held on 10.01.2023. This scheme has been placed in the present DSC meeting and recommended with some modification in name of work as well as some attachment within scheme booklet.
