Those DPRs will be placed for appraisal by the Departmental Screening Committee.

The DPRs proposed for Central Assistance, after checking by DLTC, will undergo 2nd tier checking at State TAC constituted vide this Department's Memo No.-431-IB/IW-0-IB-Misc-2019-20(pt) dated 14.01.2020 and amended subsequently before sending for appraisal at the Central Government. During implementation, the sub-schemes framed out of approved D.P.Rs of Centrally Assisted Schemes, like sub-schemes of SERP, KKB Kandi Master Plan, Teesta Barrage Project (National Project) are also to be checked and verified at DLTC, before tendering

Other content of the Department Memorandum No. 03(W) /2021-22 dated 07.07.2021 along with Ammendement Orders vide No. 05(W) /2022-23 dated 12.07.2022 and No. 12(W)/2022-23 dated 12.08.2022 will remain unchanged
