Sub: Pre-monsoon Allocation out of Maintenance Budget under State Development Scheme during 2023-24.

After careful consideration of the proposal furnished by him, the undersigned is directed to convey the in-principle approval towards Pre-monsoon Allocation of ₹ 50 Crore (Rupees Fifty Crore) only out of SDS Maintenance Budget of this Department during the current Financial Year 2023-24.

- 2. The purpose of instant Pre-monsoon Allocation of 2023-24 as follows:
 - Procurement & stacking of Flood Fighting Materials (FFM) in strategic locations.
 - Operation & Maintenance (OnM) of different Gates of water regulating structures like sluice gates, channel gates, canal gates etc
 - Minor repair (civil part) of regulating structures.
 - Petty/minor repair (such as repair of raincuts, ghoghs, assembling of dislodged boulders etc.) of Flood embankments & other flood control and river training constructions, irrigation canals and drainage channels.
 - Repair of pumping Stations (M&E).

- **6.**The expenditure to be booked under SDS(Maintenance) during 2023-24. Post facto Administrative Approval through AAFS will be accorded on Tendered Amount plus contingency subject to availability of sufficient commitment (phasing) in AAFS module and release of fund also depends on availability of maintenance fund with this Department during 2023-24.
- 7. DPRs are required to be submitted through OPMS only within 15th May'2023.
- 8. Superintending Engineers & Executive Engineers concerned are to be informed accordingly.
