Terms of Reference (ToR):

- 1. The Committee will suggest the suitable long-term measures to be taken by the TBP Authority for restoration of the damaged down stream of Teesta Barrage, Gajoldoba.
- 2. The committee will also suggest the suitable short-term measures to be taken by the TBP Authority for the upcoming monsoon, if any required.

- 3. The relevant drawings & documents will be provided to the Committee by the EE/Teesta Barrage Division and EE/Teesta Design Division, I&WDte
- 4. All logistic support will be provided by the EE/Teesta Barrage Division for this purpose.
- 5. The Chairman of the Committee may co-opt any additional "Member" into said Committee , if required, with prior intimation and consent of the concerned Chief Engineer, I&W.Dtc.
- 6. All the members shall function in addition to his normal duties.

7.The Committee will submit the Report to the Chief Engineer (Teesta Barrage Project), I&WDte. within 01 month. On the basis of the report, the Executive Engineer, Teesta Barrage Division, I&WDte. will prepare the DPR and then refer the same to the Directorate Level Technical Committee followed by Departmental Committee of Chief Engineers for scrutiny and recommendation.
