One scheme (under sl 1) for construction of RCC bridge over Noai khal near Lalpole within Block- Barasat-II, Dist- 24 Parganas (North) under Executive Engineer, Urban Drainage Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 65th Meeting held on 12.04.2023. This scheme has been placed in the present DSC meeting and recommended with some attachment within scheme booklet.
- 2. One scheme (under sl 2) for river bank protection work on left bank of river Raidak main at mouzas Newlands and Amarpur within Block-Kumargram, Dist-Alipurduar under Executive Engineer, Alipurduar Irrigation Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 66th Meeting held on 20.04.2023. This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 3. One scheme (under sl 3) for river bank protection work on right bank of river Hooghly adjacent to Acharya Jagadish Chandra Bose Indian Botanical Garden at Shibpur within Howrah Municipal Corporation in P.S.- A.J.C.Bose Botanical Garden, Dist-Howrah under Executive Engineer-I, Lower Damodar Construction Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 66th Meeting held on 20.04.2023. This scheme has been placed in the present DSC meeting and recommended with some attachment within scheme booklet.
- **4.** One scheme (under sl 4) for renovation of two Ganga Ghats on right bank of river Hooghly at Shibpur within Howrah Municipal Corporation in P.S.- Shibpur, Dist-Howrah under Executive Engineer-I, Lower Damodar Construction Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 62th Meeting held on 16.03.2023. This scheme has been placed in the present DSC meeting and recommended with some attachment within scheme booklet.

5.One scheme (under sl 5) for construction of RCC bridge over river Julkia at Chandanpur within Block-Haripal, Dist-Hooghly under Executive Engineer-II, Lower Damodar Irrigation Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 67th Meeting held on 28.04.2023. This scheme has been placed in the present DSC meeting and recommended with some attachment within scheme booklet.

6.One scheme (under sl 6) for construction of six nos box culvert at different locations within Singur Project area within Block- Singur, Dist-Hooghly under Executive Engineer-II, Lower Damodar Irrigation Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 69th Meeting held on 12.05.2023. This scheme has been placed in the present DSC meeting and recommended recommended with some attachment within scheme booklet.

7.One scheme (under sl 7) for improvement of river South Saraswati within Blocks-Sankrail and Domjur, Dist-Howrah under Executive Engineer-I, Lower Damodar Construction Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 70th Meeting held on 18.05.2023 followed by Departmental Technical Committee of Chief Engineers in their 312th Meeting on 19-05-2023. This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

- **8.** One scheme (under sl 8) for anti erosion work along right bank of river Baghirathi at Haripur, P,S-Shantipur, Dist-Nadia under Executive Engineer, Nadia Irrigation Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 64th Meeting held on 06.04.2023. This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 9. One scheme (under sl 9) for river bank protection work along left bank of river Ganga at Parlalpur near Radha Gobinda Temple within Block-Kaliachak-III, Dist-Malda under Executive Engineer, Malda Irrigation Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 69th Meeting held on 12.05.2023. This scheme has been placed in the present DSC meeting and recommended with some attachment within scheme booklet.

- 10. Two schemes (under sl 10) for river bank protection work along left bank of river Ganga at down stream of Farakka Barrage at Parlalpur within Block-Kaliachak-III, Dist-Malda under Executive Engineer, Malda Irrigation Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 69th Meeting held on 12.05.2023. This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 11. One scheme (under sl 11) for river bank protection work on left bank of river Punarbhaba at Bajra Pukur within Block-Tapan, Dist-Dakshin Dinajpur under Executive Engineer, South Dinajpur Irrigation Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 64th Meeting held on 06.04.2023. This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 12. One scheme (under sl 12) for river bank protection work on right bank of river Ganga within Dhulian municipality, P.S.-Samserganj ,Dist-Murshidabad under Executive Engineer, Ganga Anti Erosion Division No-I initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 69th Meeting held on 12.05.2023 followed by Departmental Technical Committee of Chief Engineers in their 312th Meeting on 19-05-2023. This scheme has been placed in the present DSC meeting and recommended with some attachment within scheme booklet.
- 13.One scheme for repair and maintenance of hoisting arrangements and allied works of barrage gates and head regulator gates of Teesta Barrage ,Gajoldoba within Block- Mal Dist- Jalpaiguri under Executive Engineer, Teesta Barrage Electrical Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 66th Meeting held on 20.04.2023. This scheme has been placed in the present DSC meeting and it has been resolved that this scheme has been dropped from present DSC list and fresh proposals are to be placed under SDS-Maintenance head of A/C, considering nature of works.
