Sub :- Non-availability of boulders from the quarry sites within forest area of Darjeeling and Jalpaiguri district.

Ref. :- Memo No-MDTC/SAND/011/1209,dated 12.05.2023 of the office of West Bengal Mineral Development & Trading Corporation Ltd.(WBMDTCL) (Copy enclosed).

It was informed by the Chief Engineer (N-E), I&W Dte vide his memo no.-351 dated 24.04.2023 that the progress of ongoing anti erosion works in Darjeeling and Jalpaiguri is affected due to non availability of 20-30 kg boulders from WBMTDCL controlled Boulder quarry sites within nearby forest areas.

The matter was brought to the notice of WBMTDCL vide this department's Memo No.-289-IRC dated 04.05.2023 (copy enclosed) requesting immediate streamlining of the lease granting process from the quarry sites within forest areas.

In response to the department letter no.289-IRC,dated 04.05.2023,the WBMDTCL has informed the I&W Department, that they do not operate any boulder quarry site in North Bengal for the intended size of 20-30 kg of boulders.

Moreover, the WBMDTCL has provided a copy of the SOP issued by the Forest Department vide their notification no.- 312-For/FR/O/FP/6M-11/2014 dated 23.02.2023, regarding the process to be followed for lifting of boulders from the rivers located in forest zones and obtaining permission from the Government departments and district administrations for public works by different Government Departments and organizations.

The Forest Department in their notification no.312-For/FR/O/FP/6M-11/2014,dated 23.02.2023(copy enclosed) has clearly stated that the State Government has now decided to bring the transport of boulders/sand/river bed materials originating from forest areas, including Protected Areas in North Bengal under the ambit of the e-Challan system of WBMDTCL without disturbing the system already in force under the West Bengal Forest Produce Transit Rules'2019 & the directions of the Hon'ble Supreme Court of India in the matter of I.A.No.740 of 2002 in Writ Petition(Civil)No.202 of 1995.

The undersigned is directed to request him/her to issue necessary directions to the field level officials to contact the local forest officials for getting the permission from the Forest Department for lifting of boulders/sand/river bed materials from the forest zones including the protected areas.

This is to bring to your kind attention that WBMDTCL has been appointed as the state nodal agency for sand mining as per the New Sand Mining Policy 2021 and accordingly is undertaking sand mining operations in the state. Auctions for sand mining sites are being undertaken periodically as per the NOC received from the districts and a list of the same is available in public domain on our website. The office of the undersigned is in receipt of a letter received from your good office regarding unavailability of boulders of 20-30kg at the WBMDTCL controlled quarry site. (copy enclosed)

It is in this regard that I am directed to inform you that we do not operate any boulder quarry site in North Bengal for the intended size of 20-30kg. This is also to bring to your kind attention that Forest Department has issued an SOP regarding lifting of boulders from the rivers located in forest zones and the permission is being granted for public works (copy enclosed). Whereas the State Government has started an online portal (https://mdtcl.wb.gov.in) in the West Bengal Mineral Development & Trading Corporation Ltd. (WBMDTCL) under the Department of Industries, Commerce & Enterprises, Government of West Bengal for inter alia, issuing e-Challan for transport of minor minerals including boulders, sand & river materials in the State;

And whereas transport of boulders, sand & river materials originating from the forest areas including Protected Areas in North Bengal is governed by the provisions of the West Bengal Forest Produce Transit Rules, 2019 & the directions of the Hon'ble Supreme Court of India in the matter of I.A. No. 740 of 2002 in Writ Petition (Civil) No. 202 of 1995;

And whereas for effecting better transparency, case of doing business and to plug any scope of leakage of revenue, it is desirable to have a single, uniform e-Challan for the transport of minor minerals in the State, the State Government has now decided to bring the transport of such boulders/ sand/ river bed materials originating from forests areas, including Protected Areas in North Bengal under the ambit of the e-Challan system of WBMDTCL without disturbing the system already in force under the West Bengal Forest Produce Transit Rules, 2019 & the directions of the Hon'ble Supreme Court of India in the matter of I.A. No. 740 of 2002 in Writ Petition (Civil) No. 202 of 1995.

Now, therefore, the Governor is pleased to order that all allottees of boulders, sand, river bed materials originating from any forest area including Protected Areas in North Bengal will require to generate e-Challan through the portal of WBMDTCL for transport of such forest produce (in addition to the Transit Pass issued by the Forest Department under the West Bengal Forest Produce Transit Rules, 2019).

The Standard Operating Procedure (SOP) for streamlining the process is enclosed.

Standard Operating Procedure

The State Government has decided that for transportation of minor mineral, viz., boulders, sand, river bed materials originating from any forest area including the Protected Areas in North Bengal, allottee will also require to obtain/produce e-Challan generated through the portal of West Bengal Mineral Development & Trading Corporation Limited WBMDTCL for transport of such forest produces in addition to the Transit Pass issued by the Forest Department under the West Bengal Forest Produce Transit Rules, 2019.

For streamlining the system, the following SOP is prescribed for the Field Officers of the Forest Directorate:

- 1. The existing system of issuance of allotment order for boulders/ sand/ river bed materials to the Government Departments / Government Agencies for Government works by the Forest Officers concerned and collection of all applicable receipts/ fees and issuance of transit pass required under the provisions of the West Bengal Forest Produce Transit Rules, 2019 for transport of boulders, sand & river materials originated from forest areas including the Protected Areas in North Bengal, shall continue to be followed.
- On the Allotment Order issued by the Forest Officer concerned, it shall be mentioned
 that for transport of the material/ produce the allottee SHALL require to obtain/
 produce e-Challan generated through the online portal of WBMDTCL
 (https://mdtcl.wb.gov.in).
- The Forest Officer concerned will mandatorily mark copies of the Allotment Orders of such boulder/ sand/ river bed materials issued to the different Government Departments / Government Agencies to the
 - i) District Magistrate & Collector and
 - ii) Additional District Magistrate and DL&LRO of the district(s) concerned
 - iii) General Manager, WBMDTCL
- 4. The Allottee shall prepare a data spread sheet (format enclosed) and submit it to the Additional District Magistrate and DL&LRO of the district concerned for creation of ID in the portal for generation of QR-Coded e-Challan as mandated to be carried out, in addition to the Transit Pass issued by the Forest Department.

In inviting a reference to the above memos under reference, I am directed to inform that 13(thirteen) important anti-erosion works are to be carried out before the onset of Monsoon-2023 in the districts of Jalpaiguri and Darjeeling for which around 1,05,000cum boulder is required.

It is understood from the endorsed memos that such 20-30kg boulders are not presently available at the leased quarry sites of WBMDTCL which has led to delay in physical progress.

I am therefore, directed to request you to take up appropriate measure to ensure the availability of 20-30kg boulders at the WBMDTCL controlled quarry sites, particularly, those of the rivers like Diana, Gathia ,Chel, Jaldhaka, Neora in Jalpaiguri district and river Dudhia in Darjeeling district, so that the same may be procured by the concerned contractors.
