> Subject: Registration of all Industrial Chambers/ Associations/ Industrial Units/Entities/ Demand Aggregators on Utkarsh Bangla portal.

Sir/ Madam,

Hon'ble Chief Minister reviewed Utkarsh Bangla Scheme on 11/05/2023 in presence of a large number of Departmental Heads, Chambers of Commerce, Industry Associations and Industries. The DMs were present in the meeting virtually. Subsequently the Chief Secretary held a few follow up meetings including one on 13/05/2023 where the DMs/ SDOs and BDOs were virtually present.

During the meetings it has been decided to register all the Chambers of Commerce and Associations-having presence in the State and all the industrial units/ establishments/ organizations, (which would include the public sector ones also) having more than three employees on the PBSSD Portal through the concerned departments in a time bound manner. It was also decided that this may be done on a camp mode involving the concerned district level officials of the line departments and general administration.

The registration would be done on pbssd.gov.in portal using the "Login for industry-led modules" tab. To facilitate easy onboarding the trained workforce requirement would not be mandatory right at the first step of registration and could be indicated at a later date. The nature of operations and the type of skills required for that industry would be collected at the time of registration. The registration also involves a verification by the concerned line-department officials. The line department officials are already aware of this and another instruction from your side would definitely help.

The departments may hold frequent meetings with Chambers, Associations, Industry Parks, Clusters and others working in their domain. They may be informed of the facilities and flexibilities available to them for them to associate with the employment linked training programme. The PPT prepared for Industries is attached herewith.

You are also requested to provide a list of Industrial chambers, units, entities, and demand aggregators associated with your department in the excel format attached to facilitate necessary follow-up after the onboarding.
