## NOTIFICATION

Whereas, Govt. of India in the Ministry of Road Transport & Highways has issued an advisory under number RT-23013/8/2022-T dated 10.01.2023 for suspension/ cancellation of registration of vehicles owned by Government; and

Whereas, in the said letter it was also requested to take necessary action for scrapping of Government vehicles older than 15 years and allowing tax concession on vehicles purchased after scrapping of the vehicles and grant one-time waiver scheme on the vehicles scrapped at RVSF; and

Whereas, in terms of this Department's Notification No.7964-WT dated 07.07.1989, no vehicle registered in the name of State Government is liable to pay Motor Vehicles Taxes; and

Whereas, there is no tax liability to the State Government owned vehicles, the advisory for granting concession of Motor Vehicles Tax for Government vehicles is completely complied; and

Whereas, the Ministry of Finance, Department of Expenditure, Government of India vide their F. No.44(1)/PF-S/2022-23 (CAPEX) dated 16.12.2022 has already issued amended guidelines on the Scheme for Special Assistance to States for Capital Investment for 2022-23; and

Whereas, in the said letter by the Ministry of Finance, Department of Expenditure, Government of India has set milestones for completion of activities for scrapping of all Government vehicles which are older than 15 years; and

Now, Therefore, all Heads of Offices of Government of West Bengal are advised to apply formally before the Director, Transport Directorate, West Bengal for de-registration and/or scrapping of the vehicles directly owned by the Government of West Bengal and which are older than 15 years.

This has a concurrence of Finance Department (Group-N) vide their U.O. No. 7991 dated 30.03.2023.

This shall take immediate effect.
