Sub: Additional Allocation (Converted SDRF) out of Maintenance Budget under State Development Scheme during F.Y. 2023-24 over and above 'Premonsoon Allocation of 2023-24'.

The undersigned is directed to say that in terms of the condition contained in this Department's earlier Memorandum bearing No. 34(5)–IB dated 11.05.2023, an amount of ₹ 30.17 Crore was approved as Additional Allocation for Converted SDRF during 2023-24 for the Chief Engineer (South) for the projects which are purely palliative in nature and had been taken up in conformity with the vetted (signed by the District Magistrates concerned) CA-II form in the Financial Year 2021-2022 only.

2. As reported by him, savings (due to non-fulfillment of the criteria for conversion), out of the entire approved amount, for which DPR through OPMS not generated amounts to ₹ 15.32 Crore.

- 3. This Department has received a fresh proposal from him towards redistribution of said savings as Additional Allocation in the following manner:
 - . ₹ 5.69 Crore for Basirhat Irrigation Division on SDRF during F.Y 2021-22,
 - ₹ 9.63 Crore for Basirhat Irrigation Division & 5 others on SDRF during F.Y 2022-23.
- 4. After careful consideration of the proposal and the undersigned is directed to allow the said savings of ₹ 15.32 Crore as 'Converted SDRF Allocaton' for the Financial Years 2021-2022 & 2022-2023 in the following manner:
