The Principal Secretary, TET&SD Department and Vice Chairman, PBSSD took the chair. The Project Director, PBSSD welcomed all participants in the meeting.

### 1. Loi-based Training Model

- 1.1 DPMUs to make efforts to improve the performance under LOI Module. (Action: DPMUs)
- 1.2As to the LOI obtained from the mediators / employment aggregators, the DPMUs should collect the information about the original employer before accepting the LoIs. (Action: DPMUs)
- 1.3 Portal of the PBSSD may allow for enabling a LOI withdrawal option by the TPs as in many cases the LoIs are to be rejected when TPs want to withdraw. (Action: PBSSD)
- 1.4 The quantum of target that can be assigned against the LOI shall be two times the placement demand generated by the TPs through LoIs. PBSSD to make necessary portal changes as may be required. (Action: PBSSD)

### 2. Course Rationalization

2.1 Joint meetings may be organized with the representation from the Council as well as from the PBSSD involving the TPs and DPMUs to consider the issue of rationalization of the number of courses where almost similar multiple courses are being selected. (Action: WBSCTVESD, PBSSD & DPMUS)

## 3. Handholding of Resource Personnel

3.1PBSSD may plan a suitable handholding workshop/Doubt clearance session for all DPMUs, OSDs and other staff concerned for sensitization of recent changes and amendments introduced in the different modules of the Utkarsh Bangla.(Action: PBSSD)

### 4. Post creation for Kolkata DPMU

4.1 New posts may be created for manning of skill development initiatives at the Borough level within Kolkata district as the training is suffering due to this.(Action: PBSSD)

### 5. Focus on certain industrial clusters:

5.1The industrial clusters situated at Bantala Leather Complex of (S-24 Paraganas), Foundry Cluster of Howrah, and Regent Park of North 24 Paraganas to be focused by the concerned DPMUs. (Action: DPMUs)
