Agenda: Proposal for recommendation of 11 (eleven) new schemes (10 schemes costing below Rs 5.0 crore) for inclusion under **Core SDS** for FY of **2023-24**

One scheme (under sl 1) for construction of one RCC bridge over Churial Main Khal at Khanberia, Block-Thakurpukur-Mahestala, Dist- South 24 Parganas under Executive Engineer, Suburban Drainage Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 66th Meeting held on 20.04.2023. This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 2. One scheme (under sl 2) for construction of one RCC Box bridge over Udaipur Khal, rehabilitation of one outfall sluice and one RCC Bridge over Khardah khal, P.Ss-Belgharia, Khardah, Dist-North 24 Parganas under Executive Engineer, Urban Drainage Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 77th Meeting held on 20.07.2023. This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 3. One scheme (under sl 3) for construction of boundary wall and one office building at Dabu Irrigation Sub-Division campus, Block-Canning-I, Dist-South 24 Parganas under Executive Engineer, Mograhat Drainage Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 70th Meeting held on 18.05.2023. This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 4. One scheme (under sl 4) for river bank protection work on left bank of river Hooghly at Kangali Ghat within Garulia Municipality in PS-Noapara, Dist- North 24 Parganas under Executive Engineer-I, Canals Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 78th Meeting held on 04.08.2023. This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 5. One scheme (under sl 5) for construction of one RCC Box Culvert over Dy No. N/3B at Bagpara, Block-Singur, Dist-Hooghly [initially 01 proposal under Paray Samadhan] under Executive Engineer-II, Lower Damodar Irrigation Division initially technically

recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 66th Meeting held on 20.04.2023 This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

One scheme (under sl 6) for river bank protection work along right bank of river Hooghly at Guptipara Ferry Ghat and adjacent burning ghat, Block-Balagarh, Dist-Hooghly [initially 02 proposals under Paray Samadhan] under Executive Engineer-II, Lower Damodar Irrigation Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 66th Meeting held on 20.04.2023 This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 7. One scheme (under sl 7) for improvement of Orrisha Coast Channel within Blocks-Egra-I, Egra-II, Dist- Purba Medinipur under Executive Engineer, Contai Irrigation Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 77th Meeting held on 20.07.2023 This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- **8.** One scheme (under sl 8) for protection of Sea-Dyke at Boghpur within Block-Deshpran, Dist-Purba Medinipur under Executive Engineer, Contai Irrigation Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 77th Meeting held on 20.07.2023 This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 9. One scheme (under sl 9) for protection work along left bank of river Bhagigathi at Jiaganj-Ajimgajn Municipality within P.S.-Jiajanj, Dist-Murshidabad under Executive Engineer, Berhampore Irrigation Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 44th Meeting held on 25.07.2022 This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

10. One scheme (under sl 10) for protection work along right bank of river Ganga at Dhulian Municipality and Samserganj Block, Dist-Murshidabad under Executive Engineer, Ganga Anti Erosion Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 74th Meeting held on 15.06.2023 followed by Departmental Committee of Chief Engineers in their 315th Meeting held on 03.07.2023. This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

11.One scheme (under sl 11) for replacement of total 10 no. gates of LBHR and RBHR of Durgapur Barrage in Block and PS- Barjora, Dist-Bankura under Executive Engineer, Durgapur Mechanical and Electrical Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 78th Meeting held on 04.08.2023. This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

12.One scheme for erection of fencing along left bank of lower Bagjola khal near nine vent sluice under Executive Engineer, Metropolitan Drainage Division No.-I initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 72th Meeting held on 01.06.2023. This scheme has been placed in the present DSC meeting and it has been resolved that the scheme may be booked under Administrative Expenditure subject to the Budget Provision of this Department.

13.One scheme for construction of boundary wall around one leased land to IBRAD under Executive Engineer-I, Canals Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 73th Meeting held on 08.06.2023 .This scheme has been placed in the present DSC meeting and it has been resolved that the matter may be taken up with IBRAD to execute the scheme as Deposit Work.

14.Two schemes for construction of Sluice Gates over left bank of river Banka at Palsit, Block- Burdwan-II under Executive Engineer-I, Damodar Canal Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 77th Meeting held on 20.07.2023. Both schemes have been placed in the present DSC meeting and it has been resolved that both the schemes have to be resubmitted as a

single scheme in next DSC meeting with necessary modification in name of work, some attachment within scheme booklet and incorporating mechanical component duly

technically sanctioned from Durgapur Mechanical & Electrical Division

15.One scheme for replacement of shutters of Gopia sluice, Tarapur sluice, Aluipara

sluice within block-Shantipur ,Dist-Nadia under Executive Engineer, Metropolitan

Mechanical & Electrical Division initially technically recommended by the Directorate

Level Technical Committee of I.&W.Dte. in their 79th Meeting held on 16.08.2023. The

scheme has been placed in the present DSC meeting and it has been resolved that the

scheme has to be resubmitted in next DSC meeting with necessary modification in

consultation with Executive Engineer, Nadia Irrigation Division.

16.One scheme for installation of Automatic Rain Gauge Stations within Districts

Alipurduar, Jalpaiguri, Darjeeling under Director, River Research Institute initially

technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in

their 75th Meeting held on 22.06.2023. The scheme has been placed in the present DSC

meeting and it has been resolved that the scheme may be booked under State Disaster

Mitigation Fund (SDMF).

17. Finally, 11 no. new schemes as per Annexure have been cleared by the DSC for

inclusion under Core SDS during the current FY 2023-2024.
