Agenda: Proposal for recommendation of 09 (nine) new schemes (09 schemes costing below Rs 5.0 crore) for inclusion under Core SDS for FY of 2023-24

Secretary took the chair. The following were discussed ;

1. One scheme (under sl 1) for construction of one (01) single lane RCC Bridge at Daspara over Guuniagachi branch channel Purba Jadavpur within Ward No. 109 of KMC area , PS-Purba Jadavpur ,Dist- Kolkata under Executive Engineer, Metropolitan Drainage Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 86th Meeting held on 09.11.2023.This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

2. One scheme (under sl 2) for re-construction of three (03) single lane RCC Bridges over DWF channel at Purba Jadavpur ,PSs-Bidhannagar, Kolkata Leather Complex ,Dist- South 24 pgs under Executive Engineer, Calcutta Drainage Outfall Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 82th Meeting held on 14.09.2023.This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

3. One scheme (under sl 3) for re-construction of one (01) double lane RCC Bridge over Sunti khal at Pal para ,PS-Barasat ,Dist- North 24 pgs under Executive Engineer, Bidyadhari Drainage Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 42th Meeting held on 07.07.2022.This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

4. One scheme (under sl 4) for rejuvenation of one drainage channel connecting Jamuna river and Mathura bill culvert in PS-Haringhata ,Dist- Nadia under Executive Engineer, Bidyadhari Drainage Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 86th Meeting held on 09.11.2023.This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

5. One scheme (under sl 5) for protection to the right bank of river Ganga-Padma at Alaipur , Block- Bhagwangola-II , PS-Ranitola, Dist- Murshidabad under Executive Engineer ,Ganga Anti Erosion Division-II initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 49th Meeting held on 23.09.2022 . This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

6. One scheme (under sl 6) for protection to the right bank of river Bhagirathi at Ajimganj Jainpatty in Jiaganj-Aimjanj Municipality ,PS- Jiaganj, Dist- Murshidabad under Executive Engineer , Berhampur Irrigation Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 42th Meeting held on 07.07.2022 . This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

7. One scheme (under sl 7) for protection along both bank of river Bura Dharala at Bhutkura , PS- Dinhata , Dist-Coochbehar (initially considered under Paray Samadhan) under Executive Engineer ,Coochbehar Irrigation Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 82th Meeting held on 14.09.2023. This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

8. One scheme (under sl 8) for protection along both bank of river Bangri at Lankapara Tea Garden , PS- Madarihat , Dist-Alipurduar (initially considered under Paray Samadhan) under Executive Engineer ,Alipurduar Irrigation Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 84th Meeting held on 06.10.2023. This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

9. One scheme (under sl 9) for protection along right embankment of river Hooghly at Hirapur Swasan , PS- Sankrail , Dist-Howrah under Executive Engineer-I , Lower Damodar Construction Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 62th Meeting held on 16.03.2023. This scheme has been placed in the present DSC meeting and recommended .


10. One scheme for de-siltation of Padma Nallah within Habra, Ashokenagar-Kalyangarh Municipal area , P.S- Habra , Ashokenagar, Dist- North 24 pgs under Executive Engineer, Bidyadhari Drainage Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 87th Meeting held on 24.11.2023. This scheme has been placed in the present DSC meeting and it has been resolved that the scheme is to be resubmitted in next DSC meeting after checking by the Central Design Office for additional scope of work related to slope protection against slip which may occur during de-siltation as apprehended by the concerned Executive Engineer.

11. One scheme for construction of one RCC bridge over Tangra khal (non- I&WD khal) ,within PS-Palashipara, Dist Nadia under Executive Engineer, Nadia Irrigation Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 38th Meeting held on 30.05.22. This scheme has been placed in the present DSC meeting and it has been resolved that this scheme is dropped as per prevailing bridge construction policy of this Department

12. One scheme for construction of one RCC Box culvert at confluence of Kabli khal and Birjua khal (both non- I&WD khal) ,within PS-Palashipara, Dist Nadia under Executive Engineer, Nadia Irrigation Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 43th Meeting held on 19.07.22. This scheme has been placed in the present DSC meeting and it has been resolved that this scheme is dropped as per prevailing bridge construction policy of this Department

13. Finally, 09 no. new schemes as per Annexure have been cleared by the DSC for inclusion under **Core SDS** during the current **FY 2023-2024**.

14. It has been directed to submit the soft copy (PDF version) of this scheme as per enclosed list duly technically sanctioned by the competent authority.
