ORDER

Thus, in terms of Rule No. 75 (aaa) of WBSR Part-I read with memorandum no. 6620-F dated 20.08.1981 of Finance (Audit) Department, Sri Krishnendu Shome, Junior Engineer (Civil), Suburban Drainage Division, Irrigation & Waterways Directorate, has been allowed to retire voluntarily on the ground of unavoidable personal compulsion with effect from 31.07.2025 (A.N.).
