ORDER

Sri Arup Kumar Bandyopadhyay, Junior Engineer (Civil), presently posted under Purulia Construction Division (Irrigation), Irrigation & Waterways Directorate, was appointed as **Nirman Sahayak** at Salma Gram Panchayat under Saltora Development Block, Bankura on **03/01/2006 (F.N.)** vide Memo No. 101/P&RD, dated 19/01/2007 of the Executive Officer, Bankura Zilla Parishad, Bankura in the scale of pay of Rs. 4500-9700/- of WBS (ROPA) Rules 1998.

Having been selected in the Sub-Assistant Engineers' Recruitment Examination, conducted by Public Service Commission, West Bengal and in pursuance of Memo No. 2479(48)-CIE dated- 24/07/2008 of Director of Personnel & Ex-Officio Chief Engineer, Irrigation and Waterways Directorate, **Sri Arup Kumar Bandyopadhyay** joined the post of Sub-Assistant Engineer (Civil) in Irrigation & Waterways Department on **29/07/2008(F.N.)** in the Pay Band of Rs. 9,000 - 40,500/- (PB-4) with Grade Pay Rs. 4,400/-, after being released from the post of Nirman Sahayak on **28/07/2008(A.N.)** vide Memo No. 1102/P&RD dated- 30/07/2008 of the Executive Officer, Bankura Zilla Parishad, Bankura.

Now, the Governor has been pleased to accord approval regarding counting of past service of **Sri Arup Kumar Bandyopadhyay**, Junior Engineer(Civil), Purulia Construction Division (Irrigation), **from 03/01/2006 (F.N.) to 28/07/2008 (A.N.)** rendered as Nirman Sahayak and posted at Salma Gram Panchayat of Saltora Development Block, Saltora, Bankura together with his present service towards pensionary benefits only, in terms of Finance (Pension) Department's Memorandum No 249-F (Pen) Dated: 27/05/2019 read with Rule 33(2) of D.C.R.B.
