ORDER

Sri Jyotirmay Banerjee, Executive Engineer & T.A. to Chief Engineer (North) under Irrigation & Waterways Directorate, was appointed as Sub-Assistant Engineer (Civil) under Water Resources Development Directorate on **12/09/1996(F.N.)** vide Memo No. 12205(75)/6R-1/96 dated 23/08/1996 of the Director of Personnel & Ex-Officio Chief Engineer, Water Resources Development Directorate in the scale of pay of Rs. 1390/- - 2970/-.

Having been selected in the Assistant Engineer (Civil) Recruitment Examination conducted by PSC, WB and in pursuance of Notification No. 87 dated 21/08/2006 and Memo No. 963(100)-IE-8A-4/2003(Pt. 2) dated 21/08/2006 of the Deputy Secretary to the Government of West Bengal, Irrigation Waterways Department, **Sri Jyotirmay Banerjee** joined the post of Assistant Engineer (Civil) in Irrigation & Waterways Department on **21/09/2006 (F.N.)** in the scale of pay of Rs. 8000/- - 13500/-, after being released from the post of Sub-Assistant Engineer (Civil) on **20/09/2006 (A.N.)** vide Memo No. 323(6) dated-20/09/2006 of the Assistant Engineer (A-I), Raghunathganj (A-I) Sub-Division, Raghunathganj, Murshidabad, Water Resources Development Directorate .

Now, the Governor has been pleased to accord approval regarding counting of past service in respect of **Sri Jyotirmay Banerjee**, now posted as Executive Engineer & T.A. to Chief Engineer (North), Malda, under the Irrigation & Waterways Directorate, Government of West Bengal, for the period **from 12/09/1996 (F.N.) to 20/09/2006 (A.N.)** rendered as Sub-Assistant Engineer (Civil) under Water Resource Development Directorate, Government of West Bengal, together with his present service towards pensionary benefit only, in terms of Finance (Pension) Department's Memorandum No 249-F (Pen) dated: 27/05/2019 read with Rule 33(2) of D.C.R.B.
