



MEMORANDUM

Finance Department, in their No. 8182-F(Y) dated Kolkata, the 26<sup>th</sup> September 2012, has replaced the existing Clause 25 of WBF No. 2911, in order to protect the interest of the Government and the Contractors.

This Department had issued the corresponding Departmental Notification as per guidelines of the Finance Department referred above by setting up a 'Dispute Redressal Committee in Irrigation & Waterways Department' vide GO No. 124-IB dated 16.10.2012.

Now, the nomenclature or posts/ designations of Chief Engineers have undergone a change after change in their jurisdiction. Also, the FA system has been introduced by the Finance Department in this Department.

In the above context, the Dispute Redressal Committee in the Irrigation & Waterways Department is hereby re-constituted with the following officials:

1.	Secretary, Irrigation & Waterways Department	Chairman
2.	Chief Engineer (Design & Research), Irrigation & Waterways Directorate	Member
3.	Chief Engineer relating to the tender being disputed.	Member-Secretary & convenor
4.	Financial Advisor, Irrigation & Waterways Department / FA & CO, Irrigation & Waterways Department	Member

As already implemented in the works tender including all e-tenders in this Department, the modified Clause 25 should read as "Except where otherwise provided in the contract all questions and disputes relating to the meaning of the specifications, designs, drawings and instructions hereinbefore mentioned and as to the quality of workmanship or materials used on the work or as to any other question, claim, right, matter or thing whatsoever, in any way arising out of relating to the contracts, designs, drawings, specifications, estimates, instructions, orders or these conditions or otherwise concerning the works, or the executions or failure to execute the same, whether arising during the progress of the work, or after the completion or abandonment thereof shall be dealt with as mentioned hereinafter:

If the contractor considers any work demanded of him to be outside the requirements of the contract, or disputes any drawings, record or decision given in writing by the Engineer-in-Charge or any matter in connection with or arising out of the contract or carrying out of the work, to be unacceptable, he shall promptly within 15 days request the Chairman of the Dispute Redressal Committee in writing for written instruction or decision. Thereupon, the Dispute Redressal

Committee shall give its written instructions or decision within a period of three months from date of receipt of the contractor's letter.


