TERMS AND CONDITIONS FOR PARTICIPATION IN AUCTION

(1) It shall be deemed that the bidder have thoroughly read and understood the terms and conditions of sale before participation in auction. It will also be deemed that the bidders have inspected the articles prior to the auction and have satisfied themselves with the full particulars of the same. No objection of claim of any nature whatsoever shall be entertained at the conclusion of the auction. They have to submit valid documents about the credential for similar nature of work and the amount of credential

should be minimum 50% (for a single work) of the amount of booked value of this auction along with all other documents

- (2) The Officer conducting the sale may be sufficient reasons, which he shall not bound to disclose, refuse to accept the of the highest bidder and his decision to do so shall not open question.
- (3) No materials other than above mentioned materials will be allowed to be lifted. In case of any other materials other than above lifted materials, the purchaser will be put to legal actions as per Government rules. Also no damages to any Govt, properties as well as private properties of adjacent areas during bringing of articles to be made and if done so, it will be compensated by the purchaser.
