The intending quotationers will have to apply in their own letter head to the undersigned for permission to participate in the said quotation along with copies of valid current Income Tax, Professional Tax Clearance Certificate and PAN Card in favor of the firm along with credentials incorporating successful execution of supply of similar type of items.
- 2. Last date & time of submission of application for obtaining quotation form is **05.07.2016** up to **2:00** pm.
- 3. After obtaining permission, the intending quotationers have to collect WBF **2908** along with all relevant documents from the office of the undersigned during office hours on all working days within **12.07.2016** up to **3:00** pm.
- 4. After obtaining tender paper in complete set, the participants have to quote their rates both in figure & in words inclusive of all taxes & other incidental expenditure if any in that printed form in the space provided for the purpose.
