2. The Drawing must be provided in softcopy (Total station Data) & hardcopy at a regular interval of every two days of work to the satisfaction of Engineer-in-Charge.
3. The surveyed length along the longitudinal section shall be conducive to terrain topography & cross section.
4. The survey work shall be done by total station & G.P.S whose soft copy data should be provided such that the same can be imported to G.I.S software.
5. The cross section interval should not exceed 30 m.
6. Cross section and long section will be done not less than 500 meter upstream and downstream of given location.
7. **The survey work will be time bound.**
8. **If the progress of work is not proportionate at any given time, the work order given may be summarily rejected by appropriate authority without assigning any reason.**
