- 2. The acceptance of any quotation is not obligatory and the Executive Engineer, Teesta Mechanical Division or Sub divisional Officer, Teesta Mechanical Sub Division-II, reserve the right to reject any of all the quotations received without assigning any reason.
- 3. The intending participant should thoroughly acquaint themselves with the proposed works, site/vehicle condition etc. by local inspection of the site/vehicle and he should take into consideration the difficulties likely to be involved in the execution of work or delivery of the material on the above address.
