SHORT NOTICE INVITING TENDER (OFF-LINE) No.-01 of 2016-2017 of SUPERINTENDING ENGINEER, WESTERN CIRCLE-I

- 1) Sealed Tenders in printed form W.B.F. No. 2911 are invited by the Superintending Engineer, Western Circle-I, on behalf of the Governor of West Bengal, for the work(s) as per list attached here with, from Bonafide outside contractors having experiences, credentials and resources for executing similar nature of work having experience in executing single work during last 5 (five) years for a sum equivalent to at least 30% (thirty percent) of estimated value put to tender.
- 2) The intending tenderers should apply for tender paper in the Office of the Superintending Engineer addressing to the Superintending Engineer, Western Circle-I.
- 3) Tender with requisite earnest money to be submitted in the Tender Box of the Office of the Superintending Engineer, Western Circle-I/ Office of the Executive Engineer, Howrah Irrigation Division/ Office of the Executive Engineer Hooghly Irrigation Division, as per scheduled time & date of original NIT.
- 4) a) Separate Tender should be submitted for each work, as per attached List, in sealed cover inscribing the NIT No., Sl. No. and Name of the Work on the envelope and addressing to the Superintending Engineer, Western Circle-I.
 - b) Submission of Tenders by Post or FAX or through Internet is not allowed.
- 5) The Tender Document and other relevant Particulars (if any) may be seen by the intending Tenderers or by their duly authorized representative during office hours between 11.00 A.M. And 4.00 P.M. on every working day, till the date of issue of tender papers in the office of the Superintending Engineer, Western Circle-I. Tenderers are requested to attend the bid. However, any tenderer may send his authorized representative to attend bid or any other purpose as allowed by tender accepting authority. Such authorization must be submitted in stamp paper in presence of 1st class Judicial Magistrate or Notary Public.
- 6) a) Intending Tenderers should apply for Tender Papers in their respective Letter Heads enclosing self attested copies of P.A.N./ V.A.T Registration certificate & valid P.T.P.C., and Credentials such as Completion Certificate, Work order with tender schedule of similar nature of single completed work, audited balance sheets of last three financial years, Eligibility Certificate issued by the A.R.C.S. (for Engineers' Co- operatives and Labour Co-operatives.), Partnership Deed (for Partnership Firms) and Registration from the Registrar of firms, Declaration by the Applicant to the effect that he/she/they does/do not apply for the same serial for Tender Paper for that same serial of work in this N.I.T. where he / she / they has / have common interest.
 - b) Applicants are required to produce, on demand as well as during the interview (if any), the originals of the following Documents.
 - i. Copy of P.A.N., V.A.T Registration, & valid P.T.P.C..
 - ii. Completion Certificates for similar nature of single work worth at least 50% of the value of the Work for which Tender Paper is desired, executed within last 5 (five) years from the actual year of completion.
 - iii. Eligibility Certificate issued by the A.R.C.S. (for Engineers' Co- operatives and Labour Co-operatives.)
 - iv. Partnership Deed (for Partnership Firms) and Registration from the Registrar of firms.
 - v. Declaration by the Applicant to the effect that he/she/they does/do not apply for the same serial for Tender Paper for that same serial of work in this N.I.T. where he / she / they has / have common interest.

Failure to submit and/or produce any of the above Documents may be considered good and sufficient reason for non-issuance of Tender Paper. Any suppression or misrepresentation of Fact will automatically debar the applicant

from participating in any Tender under the Circle for at least 3 (three) years from date of Detection in addition to such other penal action as the Government may deem proper.

- c) i. Completion Certificates for fully (100%) completed works during the current year and last five financial years will only be accepted. Certificates issued for partly completed works will not be considered.
 - ii. Completion Certificate of work executed in Irrigation & Waterways Department will be considered. Completion Certificate of works executed in other Departments of State Government or organizations, like Public Works & Public Works (Roads) Department, Public Health Engineering Department, Sundarban Affairs Department and various other State Government Departments, Zilla Parishads, West Bengal Housing Infra-structure Development Corporation Limited (WBHIDCO), West Bengal State Electricity Distribution Company Limited (WBSEDCL), Kolkata Metropolitan Development Authority (KMDA), Kolkata Metropolitan Water Sanitation Authority (KMW&SA), Kolkata Municipal Corporation (KMC), Hooghly River Bridge Commissioner (HRBC), Engineering Departments of Central Government and Organizations like Farakka Barrage Project (FBP) Authority, Railways, Kolkata Port Trust (KoPT), and companies owned or managed by the State Government, i.e. Mackintosh Burn Ltd., Westinghouse Saxby Farmer Limited & Britannia Engineering Ltd. may also be considered. Such Completion Certificates are to be issued by an officer not below the rank of Executive Engineer / Divisional Engineer / District Engineer / Project Manager of the other State / Central Government Departments / Organisations. Such certificates are further to be countersigned by immediate superior authority of the Issuing Authority for all cases other than direct State / Central Government Departments and Railways.
 - iii. Eligibility criteria for participating in more than one tender in a NIT: Normally separate Completion Certificate (CC) of 100% completed works is to be provided for participation in separate works in a particular NIT. However, CC for one particular work may be considered as eligible for participation in maximum two numbers of serials, provided required credential for two such works (to be arithmetically added for identical major works) satisfies the requirement in all respect from one such completion certificate.
- d) Intending Tenderers having not satisfied with the decision of the Tender Paper Issuing Authority may prefer an appeal to the next superior Officer. The communication in this regard must be brought to the notice of the Tender Issuing Authority at least before the last date of issue of Tender Paper failing which no such Appeal will be entertained.
- 7. a) No Tender Paper sent by Post will be accepted.
 - b) No Tender Paper will be issued after expiry of date & time mentioned in the notice.
 - c) Before submitting any Tender, the Intending Tenderers should make themselves acquainted thoroughly with the local conditions prevailing, by actual inspection of the site and take into consideration all factors and difficulties likely to be involved in the execution of work in all respects including transportation of materials, communication facilities, climate conditions, nature of soil, availability of local Labours and Rates prevailing in the locality etc. as no claim whatsoever will be entertained on these accounts afterwards.
 - d) Earnest money, for each work as noted in the List of Works, in the form other than those mentioned below, will not be accepted.
 - i. Receipted Challan of Reserve Bank of India or Treasury showing the Deposit to be credited under the Head 'P.W. Deposit' in favour of the Executive Engineer, Hooghly Irrigation Division.
 - ii. Crossed Bank Draft / Bankers Cheque / Deposit at call Receipt of any scheduled Bank <u>PAYABLE AT CHINSURAH IN FAVOUR OF EXECUTIVE ENGINEER, HOOGHLY IRRIGATION DIVISION OTHERWISE THE TENDER WILL BE REJECTED</u>. No adjustment of any sort of above mentioned Earnest Money previously deposited for other works will be considered. Tender without earnest money will be treated as informal.
 - e) Earnest money as noted in the list of works will have to be deposited by the contractors. <u>Anybody desirous</u> of exemption from depositing earnest money, is to furnish along with his tender, attested copy of document testifying to his having Exemption on justified grounds.

- a. The Tenderer should <u>quote the rate both in figures & in words on the basis of percentage above / below /at par the scheduled of rates attached</u> with the tender form and also in the space provided in the Tender Form.
- b. Any tender containing over writing is liable to be rejected.
- c. All corrections are to be attested under the dated signature of the Tenderer.
- f) When a Tenderer signs his tender in an Indian language, the total amount Tendered should also be written in the same language. In the case of illiterate Tenderer, the Rates Tendered should be attested by a Witness.
- g) The Tenderer who will sign on behalf of a Company or a Firm, must produce the registered documents in support of his competency to enter into an Agreement on behalf of the Company or the Firm under the Indian Partnership Act, failing which the Tender will not be considered and the deposited Earnest Money will be forfeited.
- h) Any letter or other instrument submitted separately in modification of the sealed Tender will not be entertained.
- i) The Tenderer should <u>submit a statement (if desired) at the time of submission of his application for tender showing the technical staff to be maintained for the work, with their technical qualifications.</u>
- j) Conditional Tender, which does not fulfill any of the above conditions, and is incomplete in any respect, is liable to summarily rejection.
- k) Sales Tax, Royalty and all other statutory levy / Cess etc will have to be borne by the contractor (he will have to produce necessary documentary evidence of his having done so at that time of receiving the final payment for the work) if applicable.
- 1) The Superintending Engineer, Western circle I is the accepting authority of Tender and The Tender Accepting Authority dose not bind himself to accept the lowest Tender and reserves the right to reject any or all of the Tenders received, without assigning any reason whatsoever and also reserves the right to distribute the work amongst more than one Tenderers on technical feasibility.
- m) The Tenderer will have to, if so desired and asked by the Tender Accepting Authority, submit his analysis of rate to justify the rate quoted by him.
- n) The Tenders will be opened, as specified in the List of works in the Chamber of the Superintending Engineer/ Western Circle-I in presence of the participating Tenderers or their duly Authorized Representative who may be present at the time of Opening and who may also put their signature in the Tender Opening Register.
- o) The successful Tenderer will have to execute the formal agreement in triplicate in W.B. Form No. 2911(i)/(ii) which will have to be obtained from the office of the Executive Engineer, Hooghly Irrigation Division, failing which the Earnest Money shall forthwith stand forfeited in the favour of the Government and the communication of acceptance of the tender/ Formal work order shall automatically stand cancelled.
- p) If any Tenderer withdraws his Tender before its acceptance or refuses / fails to convert it into a Contract within a reasonable time, without giving any satisfactory explanation for such withdrawal / refusal / failure, he shall be disqualified for submitting any Tender in this Division / Circle for a minimum period of one year and his case will be referred to the Government for order as to what further action will be taken against him.
- q) The successful Tenderer will have to abide by the provisions for the West Bengal Contract Labour (Regulation and Abolition) Rules, 1972 and such other Acts as may be applicable, as will be in force from time to time.

- r) Normally all the materials will be supplied by the contractor. Materials such as Cement, M.S./Tor Rod, R.C.C. Hume Pipes etc. if available in stock will be issued by the Department to the Contractor for the work as per Issue Rate fixed By The Engineer-In-Charge. Site of issue of materials as mentioned in the List of Materials to be supplied departmentally to the Contractor is furnished with the Tender Document for the work. Any other material not listed therein, if supplied by the Department, the Issue Rate for such material will be fixed by the Engineer-In-Charge.
- s) Normally all the Tools & Plants machinery will be supplied by the contractor. Hire charge for Tools & Plants machinery, if issued departmentally, will be recovered from Contractor at such rates as will be fixed by the Engineer-in-Charge. The period of Hire Charges of all Tools & Plants machinery issued from the Govt. Godown will be counted from the date of their issuance from the godown and up to the Date of return into the same godown and the Hire Charges will be recovered from Contractors accordingly. All Tools & Plants Machinery issued to the Contractor must be returned in good condition. In the case of any damage, the cost of repair of such damage or replacement will be recovered from Contractor.
- t) In the following cases a Tender may be declared informal,
 - a. Correction, alterations, additions etc. if not properly attested by the Tenderer.
 - b. Earnest Money in the form of T. R. Challan, D.C.R. / Demand Draft etc which are short deposited and / or not deposited/wrongly deposited in the favour of the Executive Engineer, Hooghly Irrigation Division.
 - c. If the Tender From is not properly filled in respect of the general Description of the work, Estimated Cost, Rate of deduction of Security Deposit etc. in page -2 and other pages as are required to be filled in.
 - d. If the specified pages of the Tender Document are not signed by the Tenderer.
 - e. If the Tender is not submitted in a Cover properly sealed and name of the work is not indicated on the cover with N.I.T No.
- u) For the refund of the Earnest Money of the unsuccessful Tenderer(s), he / they is / are to apply for the same to the Executive Engineer, Hooghly Irrigation Division, giving the reference to the work, N.I.T. No., Date of Tender, amount and mode of Earnest Money deposited – all in a complete from. The Earnest Money of All Tenderer other then the 1st, 2nd and the 3rd lowest Tenderers in each case, maybe refunded as early as possible.
- v) To verify the Competency, Capacity and Financial Stability of the intending Tenderer(s) the Issuing Authority may demand production of any necessary Document(s) as it may deem necessary.
- w) The payment of R/A as well as Final Bill for any work will be made according to the availability of specific Fund and no claim whatsoever for delayed payment will be entertained.
- x) As per I&W Deptt. G.O. No.278(8)-IB/IW/O/IB-Misc-38/2011 dt.08.12.2015 tender documents are available free of cost.
- y) The concerned Superintending Engineer, Western Circle-I, if he thinks appropriate, may conduct an interview of the applicants for the tender for verification of original documents for confirmation of the eligibility criteria.
