**1<sup>st</sup> Corrigendum against Original Notice Inviting Quotation No. 02/SDO/TCSD-III of 2017-18 circulated vide Memo No:- Q-1/123/1(16), Dated. 07.08.2017.**

This is for general information that in partial modification of this NIQ referred above the following modification have been made and to be read as follows:-

1. The Name of Work should be read as **“Hiring 1(one) no. Maxi Cab (Diesel Driven, Non AC), on daily basis for the use in the Office of the Sub-Divisional Officer, Teesta Canal Sub-Division No. III, Haptiagach, Uttar Dinajpur. (2<sup>nd</sup> Call)”** instead of “Hiring 1(one) no. Maxi Cab (Diesel Driven, Non AC), on daily basis for the use in the Office of the Sub-Divisional Officer, Teesta Canal Sub-Division No. III, Haptiagach, Uttar Dinajpur.”
2. Under the Terms and Conditions, Sl. No. 2, the clause should be read as **“The vehicle should be in good running condition”** only instead of “The vehicle should be in good running condition and should preferably conform to the BS-III or higher emission norms. The date/year of manufacturing of the vehicle should not be preferably more than four (4) years on the last date of application as mentioned in the N.I.Q.”

All other terms and conditions will remain unchanged.
